Amending Budget No 2 to the 2015 EU budget

Draft amending budget No 2 to the general budget 2015 accompanies the revision of the Multiannual Financial Framework for the years 2014-2020 (MFF) under Article 19 of Council Regulation No 1311/2013 (the MFF Regulation). The Parliament voted to consent to this revision on 15 April.

As a consequence of the late agreement on the 2014-2020 Multiannual Financial Framework (MFF), the various legal acts setting out the provisions for implementing the funds were adopted much later than planned, resulting in a delay in programming. The revision of the MFF and the adoption of Draft Amending Budget No 2 are necessary steps to fully implement the programmes under shared management, for which the 2014 allocation has not been used. All 28 Member States are concerned.

Strengthening of the 2015 EU budget

DAB 2/2015 proposes a €16 476.4 million increase in commitment appropriations in 2015 for a number of Funds under shared management, under sub-heading 1b, heading 2 and heading 3 (see the table in annex). DAB 2/2015 also intends to provide an increase of €2.5 million for the Instrument for Pre-accession Assistance (IPA II) under heading 4 (not covered by the MFF revision, therefore using the margin under heading 4). In total, DAB 2/2015 increases the 2015 budget by €16 478 918 656 in commitment appropriations. Neither the MFF Revision nor Draft Amending Budget No 2 would increase the level of payment appropriations.

After DAB 2/2015 is adopted, the 2015 Budget will amount to 161.8 billion euros in commitment appropriations and 141.2 billion euros in payments.

Concerns about payments

The Committee on Budgets welcomes the transfer of the appropriations to 2015 but expresses its concern about the long-term impact this one-year postponement will have on the overall situation on payments. Therefore it calls on the Commission to monitor the implementation to avoid 'the snowball effect of unpaid bills'.

The Commission presented Draft Amending Budget No 2/2015 on 20 January 2015. On 16 April, the European Parliament's Committee on Budgets adopted its report. The plenary vote is scheduled for the April II session (rapporteur: Eider Gardiazabal Rubial, S&D, Spain).

On 15 April 2015, European Parliament consented to the draft Council regulation amending the MFF Regulation, and therefore to the revision of the MFF (rapporteurs: Jan Olbrycht (EPP, Poland) and Isabelle Thomas (S&D, France)). The Council was due to adopt the regulation, following the EP's consent, on 21 April.
