#### **CSDP 10 years after Lisbon**

The ever-more-tense geopolitical environment has driven EU Member States and institutions, with a large public opinion support, to decide unprecedented steps towards an increased role of the EU in Security and Defence of the continent.

Ten years after the entry into force of the Treaty of Lisbon, these four studies take stock of the achievements - or lack thereof

- and remaining challenges, in issue areas crucial for the development of the CSDP. They provide targeted input to the Sub-Committee on Security and Defence (SEDE) in view of its priority setting and initiatives for the new Parliamentary term. The moment is crucial, as choices made by the EU in Security and Defence are likely to be decisive for its Strategic Autonomy, and therefore for its future.

## The mental health of workers in the digital era

#### Visibility and communication of cohesion policy in online media

This study evaluates the visibility and communication of cohesion policy in online media and the effectiveness of communication activities. The communication of cohesion policy in online media has been weak in recent years, despite the increased political priority placed on communication by EU institutions. Media coverage is often shallow, with limited



depth of understanding or analysis and there is little appreciation of the role of the EU or wider impact of the policy.

#### **EU Own Resources**

This Briefing is a background note for the Committee on Budgets public hearing on "EU Own Resources and Fiscal Policy Harmonisation: Untapped potential for Synergies?". It describes the very specific structure of the EU revenue coming from three types of own resources, i) traditional own resources, ii) VAT-based own resource and iii) GNI-based own resource. State of play of what has been done to improve own resource is



provided. Lastly, fiscal policy harmonisation initiatives are listed.
