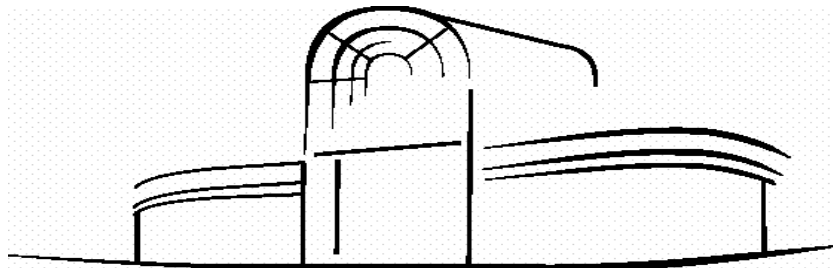

Under Article 7(1) of the Act of 20 September 1976 concerning the election of the members of the European Parliament by direct universal suffrage and Rule 4(1) and (4), Parliament took note of the election of Urmas Paet and Lefteris Christoforou with effect from 3 November 2014, Inese Vaidere with effect from 1 November 2014, and Carlos Iturgaiz and Tom Vandenkendelaere with effect from 6 November 2014.

Under Rule 3(2), until such time as their credentials had been verified or a ruling had been given on any dispute, and provided that they had previously made a written declaration stating that they did

not hold any office incompatible with that of Member of the European Parliament, Urmas Paet, Lefteris Christoforou, Carlos Iturgaiz, Tom Vandenkendelaere and Inese Vaidere would take their seats in Parliament and on its bodies and would enjoy all the rights attaching thereto.
