

#### 1. Resumption of the session

The sitting opened at 15.00.

#### 2. Approval of the minutes of the previous sitting

The minutes of the previous sitting were approved.

### 3. Requests for the waiver of parliamentary immunity

The Greek authorities had forwarded a request to waive the parliamentary immunity of Theodoros Zagorakis in relation to criminal proceedings in a court in Thessaloniki.

The Polish authorities had forwarded a request to waive the parliamentary immunity of Janusz Korwin-Mikke in relation to criminal proceedings initiated by the Warsaw District Prosecutor.

Pursuant to Rule 9(1), these requests had been referred to the committee responsible, the JURI Committee

## 4. Composition of political groups

The President announced that Amjad Bashir was no longer a member of the EFDD Group and had joined the ECR Group as from 23 January 2015.
