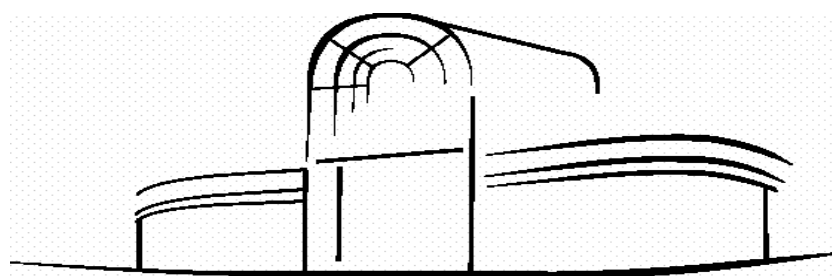

1. Resumption of the session

The sitting opened at 15.00.

2. Statements by the President

The President made a statement on the deaths of more than 400 refugees off the coast of Libya on 12 April 2015. He called on the Member States, which were responsible for migration policy, to do everything they could to remedy the situations that were leading to the influx of refugees.

The President also referred to the massacre by Al-Shabaab of 148 people at Garissa University College in Kenya on 2 April 2015.

Parliament observed a minute's silence.

The President went on to mention the plight of civilians living in the Yarmouk refugee camp in Syria and called on the United Nations to guarantee access to the camp.

3. Approval of the minutes of the previous sitting

The minutes of the previous sitting were approved.

5. Request for the waiver of parliamentary immunity

The Polish authorities had forwarded a request to waive the parliamentary immunity of Janusz Korwin-Mikke in relation to criminal proceedings brought by the police in Piotrków Trybunalski.

Pursuant to Rule 9(1), the request had been referred to the committee responsible, the JURI Committee.

6. Interpretation of the Rules of Procedure

The President informed the House, under Rule 226(3), of the following interpretation of paragraph 1 (a) of Annex XVI to the Rules of Procedure on guidelines for the approval of the Commission, which had been provided by the Committee on Constitutional Affairs, which had been consulted on the application of the provision:

'Scrutiny of the declaration of financial interests of a Commissioner-designate by the committee responsible for legal affairs consists not only in verifying that the declaration has been duly completed but also in assessing whether a conflict of interests may be inferred from the content of the declaration. It is then for the committee responsible for the hearing to decide whether or not it requires further information from the Commissioner-designate.'

If this interpretation was not contested by a political group or by at least 40 Members, in accordance with Rule 226(4), before the opening of the next sitting, on Monday 27 April 2015, it would be deemed to have been adopted. Otherwise, the matter would be put to the vote in Parliament.

The final draft agenda for the sitting of 15 April 2015 (*PE 552.729/PDOJ*) had been distributed and a number of changes had been proposed (Rule 152):

In agreement with the political groups, the President proposed to postpone to a future part-session the debate on the Commission statement on the anniversary of the Bangladesh factory fires and progress of the Bangladesh Sustainability Compact (2015/2590(RSP)).
