



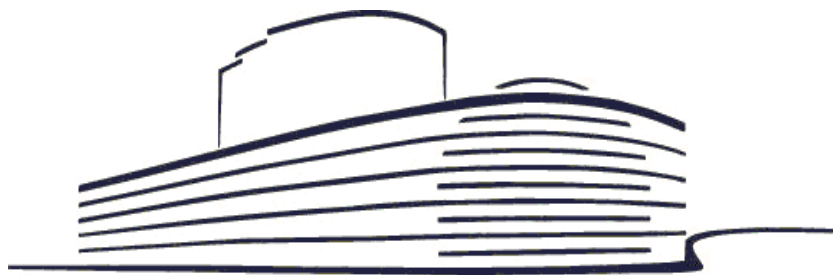

The President announced that the Conference of Presidents had approved the request of the

Committee of Inquiry to investigate alleged contraventions and maladministration in the application of Union law in relation to money laundering, tax avoidance and tax evasion, for its mandate to be extended for three months.

This extension was necessary to enable the committee to implement fully and correctly its mandate, as adopted by Parliament on 8 June 2016, given the number of documents remaining to be examined, the analyses requested, and the various stakeholders still needing to be heard.

Parliament agreed to the extension.
