



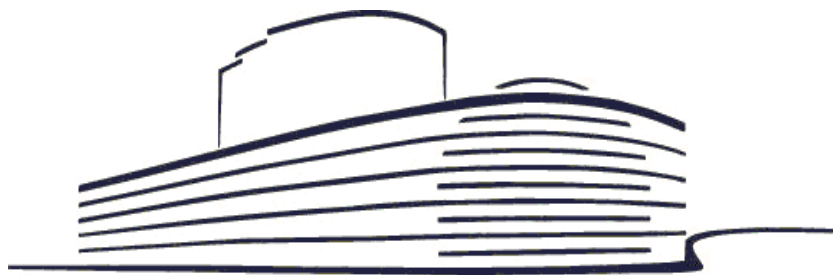

12. Composition of Parliament

The Italian authorities had given notice of the election of Giuseppe Ferrandino, Danilo Oscar Lancini and Giancarlo Scotta to replace Gianni Pittella, Matteo Salvini and Lorenzo Fontana, respectively, as Members of the European Parliament, with effect from 17 April 2018.

Under Rule 3(2), until such time as their credentials had been verified or a ruling had been given on any dispute, and provided that they had previously made a written declaration stating that they did not hold any office incompatible with that of Member of the European Parliament, Giuseppe Ferrandino, Danilo Oscar Lancini and Giancarlo Scotta would take their seats in Parliament and on its bodies and would enjoy all the rights attaching thereto.
