1. Resumption of the session

The session suspended on Thursday, 19 April 2018 was resumed.

2. Opening of the sitting

The sitting opened at 13.05.

3. Statement by the President

The President made a statement deploring the recent terrorist attacks and religious persecutions, carried out mainly by Islamic State and Boko Haram, which had taken place in the Philippines, the Central African Republic, Afghanistan and Nigeria. He conveyed Parliament's condolences to the families of the victims.

4. Approval of the minutes of the previous sitting

The minutes of the previous sitting were approved.

5. Welcome

On behalf of Parliament, the President welcomed a delegation led by His Holiness, the Patriarch of Kiev and all Rus' - Ukraine Filaret, who had taken a seat in the distinguished visitors' gallery.

6. Composition of Parliament

Jan Philipp Albrecht had given notice in writing of his resignation as Member of Parliament, with effect from 3 July 2018.

Pursuant to Rule 4, Parliament had established that his seat was vacant from that date and had informed the national authority concerned.

7. Verification of credentials

On a proposal from the JURI Committee, Parliament validated the mandates of Ana Miranda, Elsi Katainen and Miroslavs Mitrofanovs with effect from 28 February, 1 March and 5 March 2018 respectively.

8. Request for waiver of immunity

The Greek authorities had forwarded a request to waive the immunity of Georgios Kyrtsov in relation to criminal proceedings brought against him by the Court of First Instance of Athens.

Pursuant to Rule 9(1), the request had been referred to the committee responsible, the JURI Committee.
