### **1. Resumption of the session**

The session suspended Thursday 17 January 2019 was resumed.

### **2. Opening of the sitting**

The sitting opened at 15.07.

### **3. Formal sitting - International Holocaust Remembrance Day**

From 15.07 to 15.38, a formal sitting of Parliament was held on the occasion of International Holocaust Remembrance Day.

The President and Charlotte Knobloch, former president of the Central Council of Jews in Germany and current Vice-President of the European Jewish Congress and the World Jewish Congress, made speeches.

Parliament observed a minute's silence.

The Girard Quartet performed Maurice Ravel's 'Kaddish'.

*(The sitting was suspended for a short time)*

### **4. Resumption of the sitting**

The sitting resumed at 15.49.

### **5. Statement by the President**

The President Made a statement on Venezuela.

He also welcomed the family of the late Mayor of Gdańsk, Paweł Adamowicz, to the official gallery. (Parliament gave them a standing ovation).

## **6. Approval of the minutes of the previous sitting**

The minutes of the previous sitting were approved.

The following spoke Cécile Kashetu Kyenge, Krisztina Morvai, Ana Gomes and Max Andersson.

## **7. Announcement by the President**

The President announced that on 11 January 2019, the Council had approved a draft decision on the conclusion of the agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community. Parliament had therefore received a request from the Council for approval of this draft decision.

Pursuant to Annex V, paragraph XVIII(3) of the Rules of Procedure, the draft decision on the conclusion of the withdrawal agreement was referred to the Committee on Constitutional Affairs.

## **8. Composition of Parliament**

Krišjānis Kariņš had been elected Prime Minister of Latvia with effect from 23 January 2019.

Parliament noted that, pursuant to Rule 7(1) of the Act of 20 September 1976 concerning the election of the Members of the European Parliament by direct universal suffrage, this office was incompatible with that of Member of the European Parliament, and pursuant to Rule 4(1) and (4), Parliament established that the seat would be vacant as of 23 January 2019.

The Latvian authorities had given notice of the election of Aleksejs Loskutovs to replace Krišjānis Kariņš as Member of Parliament with effect from 24 January 2019.

Parliament took note of his election.

Under Rule 3(2), until such time as his credentials had been verified or a ruling had been given on any dispute, and provided that he had previously made a written declaration stating that he did not hold any office incompatible with that of Member of the European Parliament, Aleksejs Loskutovs would take his seat in Parliament and on its bodies and would enjoy all the rights attaching thereto.

## **9. Verification of credentials**

On a proposal from the JURI Committee, Parliament confirmed the validity of the mandates of Bogusław Sonik, Ralph Packet and Kārlis Šadurskis with effect from 20, 22 and 28 November 2018, respectively.
