The EP will be organising a side event on Thursday 17 December 2009 from 15.30 to 17.30 in the EU pavilion titled " A Global Carbon Market: linking 'cap and trade' systems".

This side event will provide an overview of the existing and foreseen 'cap and trade' systems including the European Union ETS and the planned 'cap and trade' scheme in the USA. Following introductions on the state of play of emission trading in different parts of the world, the event will focus on issues relating to the possibility of linking the carbon trade systems in order to create a common global market. Issues related to differences in the stringency of the caps, different credit recognition policies and the existence of price control systems will be discussed.
