The provisional agreement following inter-institutional negotiations was adopted with 33 votes in favour, 0 against and 0 abstentions.

Proposal for a regulation amending Regulation (EU) No 1316/2013 with regard to the withdrawal of the United Kingdom from the Union

The Rapporteur presented her draft report, which supports the Commission proposal's overall goal to minimise the effects of Brexit on transport links. It seeks to ensure Ireland's connectivity with mainland Europe by adding a maritime link between Ireland and other continental Member States on the North Sea in order to ensure a continuity of the North Sea - Mediterranean (NSM) corridor.

The Rapporteur took the view that the proposal focuses too much on technical details, while leaving aside the necessary long-term perspectives. In particular, she pointed out the need for preventive solutions and financing for all territories subject to Brexit's adverse effects.

The draft report therefore presents additional connections and financing tools for territories (regions in northern France and other Member States), which will be strongly affected by Brexit in social, administrative, and economic terms.

Members expressed wide support for the draft report. Some highlighted the need to include some smaller ports in the scope of CEF and mentioned the possible negative impact of the UK leaving EU agencies such as EMSA and CESNI.

The Rapporteur welcomed the Commission's proposal aimed at resolving the legal uncertainty in the area of recognised organisations by the UK's withdrawal from the EU. She noted that the proposal would safeguard business continuity for the affected ship owners and guarantee competitiveness of the flags of the EU-27 Member States working with the affected organisations. The Rapporteur therefore proposes an adoption of the Commission's proposal without amendments, also in view of the fast approaching Brexit date.

The Members expressed their support for the general aim of this proposal and the direction taken by the Rapporteur. Several Members called on the Commission to assess the overlap of responsibilities concerning the assessment of the recognised organisations by both the Commission and the Member States.

The Rapporteurs were in favour of granting discharges to the Commission, the transport agencies (EMSA, ERA and EASA) and joint undertakings SESAR and Shift2Rail. Members welcomed their positions and the overall positive results.

Some Members stressed that the discharge procedure should be an opportunity for assessment not just from

a purely financial perspective, but also in terms of broader effectiveness.

BREXIT transport and tourism: the consequences of a no-deal scenario

Presentation of a study by Policy Department

The authors of the study presented the potential impacts of a no-deal scenario, focusing on the transport, postal and tourism sectors. Although presented quite late in the Brexit process, Members agreed that the findings were still very relevant in the context of a vote in the British Parliament due next week and a vote in the European Parliament in early 2019.

The results of the study confirmed a rather pessimistic view, echoed by previous hearings held by the Committee. A no-deal Brexit would harm both sides of the Channel, with aviation and tourism being perhaps most seriously affected, at least in the short to mid-term. The experts also confirmed that ports of northern France would be affected more than most by losing considerable volume of maritime trade.

Members expressed some hope, disbelief and mostly concern for future relations between the UK and the EU. Some hoped that the option to "remain" could still prevail and the Brexit would be stopped, while others expressed disbelief that three months prior to the UK's departure, nobody really knew if, how and what would happen on 29 March 2019.

Finally, it was concluded that if bilateral agreements are to replace the current regulatory framework in transport, it would be unrealistic to expect they could be negotiated in three months if the negotiations of the Brexit deal took almost three years.
