Text proposed by the Commission

(5) The scope of this Regulation should cover public documents drawn up by authorities of the Member States and having formal evidentiary value relating to birth, death, name, marriage or registered partnership, parenthood, adoption, residence, citizenship, nationality, real estate, legal status and representation of a company or other undertaking, intellectual property rights and absence of a criminal record. Simplification of the acceptance of these categories of public documents between the Member States should bring tangible benefits to Union citizens and companies or other undertakings. Because of their different legal nature, documents drawn up by private persons should be excluded from its scope. Documents drawn up by authorities of third countries should likewise fall outside the scope of this Regulation.

(5) The scope of this Regulation should cover public documents drawn up by authorities of the Member States and having formal evidentiary value which are extracts from the register (birth, marriage and death certificates, proof of the conclusion of a registered partnership, etc.) as well as listings from other public registers, in particular the population register and the register of intellectual property, and extracts from the criminal register, the land register and credit bureau and, finally, the companies register. Simplification of the acceptance of these categories of public documents between the Member States should bring tangible benefits to Union citizens and companies or other undertakings. Because of their different legal nature, documents drawn up by private persons should be excluded from its scope. Documents drawn up by authorities of third countries should likewise fall outside the scope of this Regulation.
