(1) The Multiannual Financial Framework does not fund any militar expense, nor expenses related to security and defense, including in what does respect to R&D

(2) The sum of “Economic, social and territorial cohesion” and “Natural Resources and Environment” budget lines shall represent, at least, 45% of global appropriations.

Or. enJustification

The appropriations proposed are extremely exiguous and insufficient to guarantee the principle of economic, social and territorial cohesion. Therefore, and by safeguarding the European Parliament role, it is proposed a global reconsideration of the figures, as well as its substantial increase, speacially in what does respect to the title “Economic, social and territorial cohesion”.
