

Invites the European Court of Auditors to collect additional and necessary documents and information, for which the Joint Undertaking is not empowered to require, from the national audit bodies of the Member States and/or the national competent departments, in accordance with the provisions of Article 287(3) of the Treaty on the Functioning of the European Union. Moreover, invites the Court to use this additional information as an alternative way to justify its opinion and to report to the discharge authority on its assessment of these additional elements.
