Subject: Freedom of expression under threat in Spain

This week Mallorcan rapper Valtònyc was sentenced to three and a half years in jail by the Spanish Supreme Court for exaltation of terrorism and slander against the Crown in his song lyrics¹. Earlier this week, a court ordered copies of a book entitled 'Fariña', which reveals the relationship between drug traffickers and certain politicians, to be seized and its printing and sales to be halted², and an art piece on political prisoners in Spain was withdrawn from the ARCO art exhibition³. Rapper Pablo Hasél, accused of slander against the Crown and the state, is also awaiting the outcome of his trial and could be sent to prison⁴.

The European Court of Human Rights has ruled that Article 490 of the Spanish Criminal Code, which protects certain institutions against public offence, is not in line with Article 10 of the European Convention on Human Rights. This article remains unchanged and constitutes the legal basis for the abovementioned rulings.

Does the Commission consider that Spanish Law 4/2015 and the Spanish Criminal Code are fully in line with Articles 11 and 12 of the Charter of Fundamental Rights of the European Union?
