## Question for written answer E-006341/2018 to the Commission Rule 130 Dominique Martin (ENF)

Subject: 'Gilets jaunes' robbed to build motorways and hospitals in Romania

The European Commissioner for Regional Policy, a Romanian, declared on 8 November 2018 that she was proud to work for her country and to have increased the regional funds for Romania<sup>1</sup> by 10 % between 2021 and 2027. She clearly has true European ambitions. To feed those ambitions, Brussels is said to have earmarked more than EUR 100 billion to Romania for the period between 2007 and 2027, including some EUR 10 billion from the European Social Fund.<sup>2</sup>

The Bucharest ring road and four hospitals are being built<sup>34</sup> using EU funds mostly from Germany, France and Italy: EUR 300 million per hospital and EUR 1.3 billion for the ring road<sup>5</sup> – EUR 2.5 billion in total.

In France, maternity wards and dozens of hospitals are being closed or are at risk of closure in places such as Altkirch, Vierzon ou Saint-Lô, in an effort to save EUR 1 billion.<sup>6</sup>

Why are hospitals being closed in France to pay for the construction of hospitals in Romania?

Why has the task of constructing motorways in Romania, which is largely being paid for by the French and Germans (EUR 1.4 billion), been given to a US group?<sup>7</sup>

After a number of modifications and renegotiations, however, the agreement with Bechtel was broken off in 2013.
