We now need to move this agenda forward at Member States' and regional level with the support of the **European Social Fund**, paying particular attention to basic skills and to digital skills."

"There is still work to do if we are to ensure that social fairness and labour rights are hallmarks of

the single market. The Commission will address **labour mobility and social security coordination** challenges by proposing a **European Labour Authority** and a multi-purpose **European social security number** that will simplify citizen's interactions with administrations in a range of areas. We will propose to modernise social security systems, taking into account new forms of work to **close the gaps so that everyone who works, irrespective of employment status, can contribute and have access to social protection coverage**. To further safeguard and protect workers in the single market the Commission will propose reinforced obligations to make sure employees are informed in writing about their working conditions."

The EMPL Secretariat has been made aware that ECON Coordinators discussed the working method linked to the report on the Economic policies of the euro area (2nd annual INI report in the Semester cycle, with a Rule 54 EMPL opinion) and decided to opt for two separate reports (ECON & EMPL).

[The fall-back option of ECON would be a Rule 54 EMPL opinion with strict implementation of the rules on competences. In this case, ECON suggests preparing a vademecum to explain the criteria on the evaluation of the EMPL AMs to be included in the ECON report (also as regards their maximum acceptable length).]
