PROCEDURAL REMARKS

The EMPL committee was associated to the TRAN committee's report on the abovementioned dossier under Rule 54 with shared competence for the whole text of the Commission proposal.

On 25 April 2018, EMPL adopted its opinion (43 amendments) and on 4 June, TRAN adopted its report. On 14 June 2018, the plenary rejected the TRAN committee's decision to enter into negotiations and therefore the TRAN report was placed on the agenda of the July 2018 plenary, in accordance with Rule 69c(3). On 4 July 2018, the Plenary referred the file back to the TRAN Committee. On 10 January 2019, the TRAN Committee voted on the above-mentioned file. No TRAN amendments have been adopted. A large majority of political groups in TRAN is now in favour of recommending the Conference of Presidents to place the 3 mobility package files on a plenary agenda.

Rule 54(1), fourth indent allows for the following: *"if amendments on matters which fall*

within the shared competence of the committee responsible and an associated committee are not adopted by the committee responsible, the associated committee may table those amendments directly in plenary;"

PROCEDURAL REMARKS

The EMPL committee was associated to the TRAN committee's report on the abovementioned dossier under Rule 54 with shared competence for Article 1 of the Commission proposal, which amends the Driving Time Regulation (561/2006).

On 25 April 2018, EMPL adopted its opinion (34 amendments) and on 4 June, TRAN adopted its report. On 14 June 2018, the plenary rejected the TRAN committee's decision to enter into negotiations and therefore the TRAN report was placed on the agenda of the July 2018 plenary, in accordance with Rule 69c(3). On 4 July 2018, the Plenary referred the file back to the TRAN Committee. On 10 January 2019, the TRAN Committee voted on the above-mentioned file. No TRAN amendments have been adopted. A large majority of political groups in TRAN is now in favour of recommending the Conference of Presidents to place the 3 mobility package files on a plenary agenda.

Rule 54(1), fourth indent allows for the following: *"if amendments on matters which fall within the shared competence of the committee responsible and an associated committee are not adopted by the committee responsible, the associated committee may table those amendments directly in plenary;"*

Amendments 11, 12, 30, 31, 32, 33 and 34 from the EMPL opinion relate to Article 2 of the Commission proposal, which amends the Regulation on Tachographs (165/2014).

=> **EMPL cannot table those amendments in plenary** because the committee did not have shared competence => Rule 53(7) applies:

"7. Opinion-giving committees within the meaning of this Rule cannot table amendments for consideration by Parliament."

Amendments 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28 and 29 fall within the **shared competence** of TRAN and EMPL and were not adopted by TRAN

=> **The EMPL committee may choose to table them in plenary**
