*The only justification for allowing the marketing of nicotine containing products (NCPs) is for cessation purposes. It is very difficult to assess the nicotine delivery of NCPs. An intensive use of NCPs with a low level of nicotine could still lead to significant nicotine intake. It is thus appropriate to subject all NCPs to pharmaceutical legislation. This would ensure the quality, safety and efficacy of NCPs, as well as a level playing field for all nicotine containing products.*
