1. Chair's announcements

1.1. Meeting organisation

Decision:

- *Agreed that Coordinators' meeting will take place at the end of the first half-day of the committee meeting. In exceptional circumstances, Chairman would convene the meeting at another time slot.*
- *Agreed that the voting time will take place either at 10.00 or at 16.00. If the meeting is three half-days, on the second day, at 10.00. If the meeting is two half-days, in the second half-session at 10:00 or 16:00.*
- *Agreed that only Coordinators are invited to the Coordinators' meetings. Vice-Chairs could be invited, in order to replace the Chairman or in exceptional cases.*
- *Agreed that invitations to Coordinators' meetings will also include the appointed person of the secretariat of the non-attached Members.*

1.3. Preparation for the hearing(s) of Commissioner(s)-designate

Decision:

- Took note of the procedure concerning preparation of five written questions to the Commissioner-designate for Trade, and invited the political groups to submit to the Secretariat by 27 August their comments in view of subsequent discussion at next Coordinators meeting;
- Postponed until next Coordinators meeting the decision on which other hearings INTA should be associated to or invited to, depending on the allocation of portfolios and tasks among the Commissioners-designate.

2. System for allocation of reports and opinions to political groups

Decision: To continue the same system for allocation of reports and opinions as in the 8th legislative term.

3. Guidelines on monitoring groups and appointment of standing rapporteurs

Decision:

- Agreed in principle that INTA would continue with the past practice of establishing INTA Monitoring Groups and appointing INTA Standing Rapporteurs, and approved the modified “INTA Guidelines on Standing Rapporteurs and Monitoring Groups for negotiations and implementation of international trade and investment agreement”;
- Invited the political groups to submit to the Secretariat by 27 August their suggestions concerning the list of Monitoring Groups, in view of subsequent discussion at next Coordinators meeting; postponed until next Coordinators meeting the decision on the exact list of Monitoring Groups, and postponed until 23 September Coordinators meeting the decision on the allocation of Monitoring Groups among political groups in accordance with the proportional d’Hondt allocation system.

4. Guidelines on delegated and implementing acts

Decision: Approved the updated “INTA Guidelines on delegated and implementing acts”.

5. Guidelines on trilogues

Decision: Approved the updated “INTA Guidelines on interinstitutional negotiations in ordinary legislative procedures”.

6. Rules governing voting in INTA Committee

Decision: Approved the updated “Rules governing voting in INTA Committee”.

7. Procedures held over from 8th legislature

Decision:

- *Confirmed to continue with all 4 legislative proposals which were not finalised under the 8th legislative term (2016/0295(COD), 2012/0060(COD), 2004/0148(COD), 2015/0027(COD)), and confirmed the allocation of three of these reports (except for 2004/0148(COD), that is frozen and could remain not attributed for the time being) to the rapporteurs/political groups that had rapporteurship during the previous legislative term for 0 points. Requested all political groups whose rapporteurship was re-confirmed, but where rapporteur is no longer a member of INTA, to appoint a rapporteur and communicate it to the INTA Secretariat as soon as possible.*
- *Postponed the decision on allocation of 12 non-legislative procedures which were not finalised under the 8th legislative term (2019/0132(NLE), 2019/0099(NLE), 2018/0356(NLE), 2018/0358(NLE), 2016/0038(NLE), 2015/0203(NLE), 2015/0012(NLE), 2014/0267(NLE), 2013/0329(NLE), 2013/0273(NLE), 2008/0113(NLE), 2013/0159(NLE)) until a decision on standing rapporteurs has been taken.*
- *Confirmed the decision by previous INTA Coordinators to draft opinions to 5 procedures which were not finalised under the 8th legislative term (2019/2010(BUD), 2018/0166(APP), 2018/0427(NLE), 2017/0035(COD), 2016/0195(NLE)). Confirmed the allocation of the opinions to the draftsman/political groups to which it was attributed during the previous legislative term for 0 points. Requested all political groups whose rapporteurship was re-confirmed, but where rapporteur for opinion is no longer a member of INTA, to appoint a rapporteur for opinion and communicate it to the INTA Secretariat as soon as possible.*

- *Agreed to continue using the present system of applying the rolling d'Hondt method for both internal missions and external ad-hoc delegations based on separate tables, with rapporteur, chair and standing delegation chair not subject to d'Hondt and guaranteed automatic seats, d'Hondt tables not reset throughout the term, no saving of unused slots, the application of the overall size of the political groups in case of ties.*
