



MINUTES

Meeting of 26 March 2018, 15.00-18.30,
and 27 March 2018, 9.30-12.30 and 14.30-17.00
BRUSSELS

The meeting opened at 15:06 on 26 March 2018, with Claude Moraes (Chair) presiding.

1. Adoption of agenda

The draft agenda was adopted with the following changes:

- Point 7 on the 2019 budget - Trilogue mandate was postponed.
- Point 9 on the reporting back to committee on the trilogue negotiations on mutual recognition of freezing and confiscation orders was postponed
- Points 17 to 21 on the votes on the new psychoactive substances were cancelled. The Chair indicated that those 5 substances are now covered by the UN Conventions on drug control and are automatically included in the EU definition of drugs for the purpose of combating illicit drug trafficking, following a decision of the UN Commission on Narcotic Drugs of 14 March 2018. The Council has informed the European Parliament that there is no need anymore to adopt implementing decisions on those five NPS. The Council letters have been forwarded to the LIBE Members.

2. Chair's announcements

The Chair indicated that interpretation in Danish, Croatian and Gaelic would not be available on both days, 26 and 27 March 2018.

Delegated an implementing acts

The Chair reminded that on 20 March 2018 and 22 March 2018, the European Parliament received in total 3 Draft Commission implementing decisions for which the basic act is Regulation (EU) 2017/2226 establishing an Entry/Exit System (EES).

1. The first "laying down the specifications for the quality, resolution and use of fingerprints for biometric verification and identification in the Entry/Exit System (EES)" was received on 22 March 2018;

2. The second "laying down measures for the establishment and the high level design of interoperability between the Entry/Exit System (EES) and the Visa Information System (VIS)"; and
3. the third "laying down measures keeping and accessing the logs in the Entry/Exit System (EES)"; were received on 20 March 2018.

The Chair reminded that the reception of these implementing acts was communicated to all LIBE Members via the LIBE DIA Newsletter of 23 March 2018 and that an internal deadline for proposing an objection was set.

The Chair reminded that in case any Member wanted to raise an objection, they should inform the LIBE Secretariat before 3 April 2018.
