MINUTES

Meeting of 24 September 2014, 9.00-12.30 and 15.00-17.30
BRUSSELS

The meeting opened at 9.05 on Wednesday, 24 September 2014, with Cecilia Wikström (Chair) presiding.

1. Adoption of agenda **PETI_OJ (2014)235_1**

The agenda of the present meeting was adopted unanimously.

2. Chairman's announcements

No announcements were made.

3. Any other business

Mrs. M. Giuffrida reiterated the pressing need for a fact-finding visit to the island of Lampedusa in Italy, as migratory flows to Europe continue to rise. The Chair took note of the request.

4. Chairman's announcements regarding the coordinators' meeting

1) Information on pending Reports

a) Appointment of a rapporteur for the "Report on the annual report on the activities of the European Ombudsman in 2013"

The coordinators agreed to the appointment of Mr. Jarosław WAŁĘSA (EPP) as a rapporteur. Shadow rapporteurs will be appointed and communicated to the Secretariat by the other political groups within one week.

b) Appointment of a rapporteur for the Annual Report of the activities of the Committee on Petitions 2014

According to the allocation of reports by the d' Hondt system, the rapporteur shall originate from the S&D group and is to be indicated in the immediate future. Shadow rapporteurs will be communicated to the Secretariat by the other political groups within a week.

2) Webportal - update of the state of play

The Chair reminded the coordinators of their unanimous decision taken at the end of the previous legislature to launch the web portal as soon as possible. A meeting of the steering committee is to take place in the morning of Friday, September 26, 2014 to iron out the final (mainly technical) details, so that the web portal can be launched in the next few weeks.

3) Hearing of an unsuccessful European Citizens' Initiative

The organizers of an unsuccessful ECI (*Title: End Ecocide in Europe: A Citizens' Initiative to give the Earth Rights*) would like to submit it to the attention of the PETI Committee during one of the following committee meetings under rule 218.

It was agreed that it will be itemised for discussion in the same way as a petition in a future PETI meeting. However, timing will be deferred, due to the heavy workload in PETI. It was noted that it should be considered as a possibility for the committee to hear these cases and not as an obligation.

As regards other eventual requests by unsuccessful ECIs, the possibility of their discussion in a PETI meeting will be decided on a case-by-case basis, given the fact that priority will be given to the reduction of the existing backlog in current petitions.

4) Programming of committee hearings in 2015

The coordinators agreed to hold a hearing on the application of the ECI Regulation, targeted for March 2015. This hearing will be held in close cooperation with the AFCO Committee and the Policy Department which has just published the expert report on this issue and which could be further updated before such a hearing. To this end, AFCO will be consulted and a letter of information will be sent to the Chairman of the Conference of Committee Chairs.

Proposals for further hearings are to be submitted by the political groups to the PETI Secretariat within one week.

5) Statement by the Chairman regarding the responsibilities of the Petitions Committee

The coordinators agreed that the reflection document circulated by the Chair on this matter constitutes a positive basis for discussion. Further suggestions and comments by the political groups are to be submitted as soon as possible.

6) Any other business. Items for information

a) Pending proposals for fact-finding visits

The Chair reminded the coordinators that, given the current backlog in the process of handling petitions, no fact-finding visits should be organized until the end of 2014.

The coordinators noted the fact-finding visits already envisaged in the previous legislature (Ebro River, 'Via Carpathia' road, Ireland and child protection matters in the UK).

A letter will be sent to the Chairman of the Conference of Committee Chairs, informing him that about three such visits could take place during 2015 but that an individual request would be submitted on an ad hoc basis in line with rule 216-5. The request for an additional visit on the subject of migration in the Southern Mediterranean (Lampedusa etc) was also noted.

As a point of principle it was agreed that no visit should be envisaged until and unless a thorough discussion had been held in Committee on the petitions concerned beforehand. Only then would the Coordinators consider the option for a fact-finding visit.

It was furthermore noted that prior to deciding on a fact finding mission there shall be an appropriate stock taking in order to make full use of the work of other committees in the parliament.

Any additional requests should be submitted in writing and discussed at the next Coordinators' meeting.

b) Election of the European Ombudsman

Members noted the procedure was now open. It was unanimously agreed that the Chair would address a letter to President Schulz about transparency matters pertaining to the candidatures for the position of the European Ombudsman, and especially about the disclosure of the names of the Members that have supported specific nominations.

c) Hearings of new Commissioners-designate (decision of the Conference of Committee Chairs)

The coordinators noted that PETI is invited to participate in the hearing of Commissioner - designate Timmermans (First Vice President), which is to take place in the afternoon of October 7th, 2014. Confirmation was also received about PETI's participation in the hearing of Commissioner - designate Navracsics (Education, Culture, Youth and Citizenship) that is scheduled to take place in the evening of October 1st, 2014. Speakers are to be given speaking time by their political groups.

d) Potential visit by the Scottish Parliament's Public Petitions Committee

The coordinators welcome the visit of the Scottish Petitions Committee on the occasion of the PETI meeting of December 1, 2014. A draft programme will be arranged and submitted to the Coordinators in due course, following consultations with Edinburgh.

e) List of PETI Committee meetings

The list of PETI Committee meetings for 2014 and a calendar for the 2015 meetings circulated to the coordinators were approved.

f) Legal opinion concerning a claimed copyright infringement in relation to a reference to the legal work of the Polish lawyer, Mr Krzysztof Uczkiewicz, in the "Working Document on the fact-finding mission to Lower Silesia, Poland 29-31 May 2013".

Coordinators mandated the secretariat, in consultation with the Legal Service, to address a letter to the Polish author, extending the Committee's apologies for the incident, explaining the light in which his article was mentioned and for what reason.

7) Draft agendas:

The draft agenda for the October 2014 meeting has already been circulated to the coordinators and is to be approved by written procedure. Coordinators are kindly

requested to submit their remarks until 10am Friday, September 26, 2014.

5. Presentation by the European Commission of its cooperation with the Committee on Petitions

The presentation was made by Mr. Pascal Leardini, Head of Directorate F at the Secretariat General of the European Commission (EC), who stressed the considerable increase of 45% in petitions in the past year, out of which a large percentage is sent to the Commission for its opinion. The four main subject areas of these petitions are the environment, fundamental rights, free movement of citizens and workers, as well as the economic and social crisis. After describing the internal procedure followed by the Commission in the processing of petitions, the key issues encountered in this cooperation were identified, namely the need for a closer admissibility check of the petitions addressed to the EC, the requirement for involvement of the MS and their authorities, the presence of EC officials in preparation meetings and finally the large number of open petitions, which increases the workload considerably. For the improvement of the existing close cooperation, the EC proposed solutions that correspond to the main issues, among which the invitation of MS authorities in meetings and the wider use of existing resolution tools.

PETI members were informed about infringement procedures and the state of play in processing of petitions by the EC, who acts in its role as a guardian of the EU Treaties. An effort is made by the Secretariat to divert current petitioners to other sources of information and guidance than the EC. Questions were posed by members Margarete Auken, Peter Jahr, Soledad Cabezón Ruiz, Notis Marias, Eleni Theocharous and Beatriz Becerra Basterrechea, and were answered accordingly by Mr. Leardini.

6. Presentation by the Legal Service of its cooperation with the Committee on Petitions

The presentation was made by Mr. Antonio Caiola, Head of Unit of the Legal Service of the European Parliament, who proceeded to give a brief outline of its competences, i.e. that it represents the EP before all courts and offers (written or informal) legal advice to any of the EP bodies. Extensive reference was made to the judgements of the General Court of the EU that refer to petitions and their processing; the cases at hand are separated in two categories, i.e. cases where petitions considered to be inadmissible, with case T-308/07 (Ingo-Jens Tegebauer v European Parliament) being the most prominent. It was stipulated in its rationale that for any decision taken by PETI on admissibility there needs to be a full and clear justification. The same principle was reiterated in subsequent judgements, such as T- 280/09 (José Carlos Morte Navarro v European Parliament) and T-160/10 (J v European Parliament). The second category comprises cases pertaining to decisions by PETI to close a petition, the first case on this being T-186/11 (Peter Schönberger v European Parliament). PETI had found a petition to be admissible; subsequently the Secretariat closed the petition and forwarded the matter to DG Personnel. This decision by the Secretariat was contested by the petitioner and the Court found that the action taken ought to be annulled, as there can be no redress against it. This view was repeated in other cases, such as case T-650/13 (Zoltán Lomnici v European Parliament). Finally reference was made to the appeal filed by the petitioner in the Schönberger case (now no. C-261/13). Although no judgement has been issued yet, Advocate General Jääskinen

interpreted the provisions on the light to petition in a new light, indicated that PETI may decide to dismiss a petition as inadmissible without the petitioner having any redress against this decision, thus fully overturning the Tegebauer jurisprudence. It remains to be seen whether the Court will adopt the views of the AG in its future judgement.

A. Petitions for discussion in committee on the basis of the Commission's written reply or other documents received

7. Petition 0454/2009 by Wendy Clark (British), on behalf of Port Services (Invergordon) Ltd., on alleged abuse of dominant position by the Cromarty Firth Port Authority (Scotland)

Speakers: Hubert de Broca (European Commission – EC)

The Chairman announced that the petitioner addressed a letter to the PETI Committee indicating a mediation procedure had been initiated by the Scottish authorities.

Decision: Based on the letter received by the petitioner about mediation being in progress, a special letter is to be sent to the Scottish authorities supporting the mediation process and the petition closed.

8. Petition 0338/2010 by T.F.T (Spanish), on behalf of the ‘Plataforma por la defensa de los valles verdes’, on water catchment facilities and the sinking of wells in the ‘Sierra de Cazorla’, wildlife park in Segura y las Villas, Jaén

Speakers: R.G. (on behalf of the petitioner), José Severt Martin (EC), Soledad Cabezón Ruiz, Beatriz Becerra Basterrechea

Decision: The petition is to remain open. Additional information is to be received from the EC, which is to keep PETI informed about the exact location of the facilities to be constructed in the future outside the water catching area, as they would need to be of a sufficient distance to prevent any impact on the protected zone.

9. Presentation by the European Ombudsman, Mrs Emily O'Reilly, of her Annual Report for the year 2013

The European Ombudsman, Ms. Emily O'Reilly, presented to PETI her Annual Report for the previous calendar year. Following a brief overview of the main events of last year, Ms. O'Reilly presented the number of citizens that were helped by her office in 2013, the number of inquiries opened and closed that year, the institutions concerned in the inquiries opened, the results of the inquiries opened, the percentage of compliance with the Ombudsman's decisions, and finally the country statistics for complaints received and inquiries initiated. She identified the key topics investigated as part of her activities (transparency, ethical issues, citizens' participation, EU-funded projects, fundamental rights and culture of service) and gave her outlook for the future with the main axis of her activities (impact, relevance, visibility), as well as the current on-going strategic investigations.

Subsequently, questions were posed by Members Margarete Auken, Notis Marias, Jarosław Leszek Wałęsa (Rapporteur), Michèle Rivasi, Soledad Cabezón Ruiz, Angela Vallina, Pál Csáky, Beatriz Becerra Basterrechea and Roberta Metsola, which were answered accordingly by Ms. O'Reilly.

Petition 1137/2013 by Konstantia Stoiou (Greek), on behalf of the Assiros 'Friends of the Earth' environmental association, the Lagkadas environmental association and the Thessaloniki ecological association, concerning the infringement of national and EU environmental legislation resulting from the operation of the Mavrorachi landfill site in the province of Thessaloniki**

Speakers: Dimitrios Megkas and Christos Chatziparadisis (on behalf of the petitioners), Paul Speight (EC), Vassilios Liogkas (Greek Ministry of Environment and Climate Change)

- 11. Petition 0742/2007 by Andreas Varnakiotis (Greek), on the siting of a refuse tip in Achaia (Greece)**

Joint decision for petitions under no.10 and 11: The petitions are to be kept open. Letters should be addressed to the regional authorities and management authorities of the landfills to clarify whether the environmental directives are implemented, what measures have been taken by these authorities in terms of waste cycle prevention, recycling and incineration, and whether any specific measures have been undertaken against leachates and the contamination of surface and ground waters.

- 12. Petition 0258/2011 by Karen Everett (British), with 679 signatures, on pollution of the water at Western Beach, Gibraltar, by Escherichia coli bacteria, allegedly caused by sewage from Spain**

Decision: The petition is to be kept open. A letter is to be addressed to the Gibraltar authorities to request clarification about the state of the beach and whether any measures have been taken about the plant.

- 13. Petition 1102/2009 by Gerard Cussinet (French), on behalf of the Association de Défense pour le Droit au Logement et à la Consommation, on pollution caused by the improper use of the Cusset waste disposal site (Vichy Val d'Allier, France)**

Decision: The petition is to be closed

- 14. Petition 1377/2010 by M.P. (Polish), on behalf of the citizens' pressure group 'Terra', bearing 5300 signatures, on industrial pollution in the town of Szczecinek, north-west Poland**

Speakers: Jill Michielssen (EC), Julia Pitera

Decision: The petition is to remain open. As the European Commission is in further exchanges with the Polish authorities, PETI will also contact these to inquire about the present situation.

15. Petition 1770/2009 by Carlo Crotti (Italian), on behalf of Ass "Salvanguardia idraulica del territorio padovano e veneziano", on possible infringement of Directive 2007/60/EC on the assessment and management of flood risks by the construction of a motorway from Venice to Padova

Speakers: Ioannis Kavvadas (EC), Eleonora Evi

Decision: The petition is to remain open. The European Commission is to offer PETI some additional information on the matter, notably on the infringement procedure.

16. Presentation of the Study on the "European Citizens' Initiative – First lessons of implementation"

The study was presented by Ms. Marta Ballesteros, a representative of Milieu Ltd a consulting firm who was assigned by Policy Department C to produce this report. After presenting the legal basis of the ECI in primary and secondary EU law, Ms. Ballesteros explained the objectives of the study, which were to identify obstacles organisers face in setting up and running a European Citizens' Initiative (ECI), to analyse possible solutions to overcome such obstacles and to suggest recommendations to improve the functioning of the ECI. The key findings of the study were identified in the following areas: in the online certification system; in the registration of the ECI by the EC; in the online collection system; in the collection of signature by the citizens; in the verification of signatures by member states and finally in the submission of the ECI to the EC. The practical recommendations refer to the availability of IT infrastructure (hardware and software) by the EC, to the revision of the relevant Regulation and Treaty article and to the translation requirement.

Questions were subsequently posed by Marie-Christine Pironnet (EC) and members Tatjana Ždanoka, Sylvia-Yvonne Kaufmann, Notis Marias, Peter Jahr, Roberta Metsola and answered by the speaker.
