

The President made a statement to commemorate the 20<sup>th</sup> anniversary of the formation of the Lithuanian independence movement, Sąjūdis, which had laid the foundations for the reestablishment of Lithuania's independence.

He also mentioned the Green Weeks that would be held in Brussels, Luxembourg and Strasbourg and drew attention to Parliament's undertakings to reduce CO<sub>2</sub> emissions.

The Greek authorities had given notice of the appointment of Kostantinos Droutsas to replace Diamanto Manolakou as Member of Parliament with effect from 03.06.2008.

In accordance with Rule 3(2), as their credentials had not been verified or a ruling given on any dispute, Elisabetta Gardini, Giovanni Robusti and Kostantinos Droutsas would take their seats in the European Parliament and its bodies and enjoy all the rights attaching thereto, provided that they had previously signed the declaration that they did not hold any office incompatible with that of Member of the European Parliament.
