15a. Calls for the EU and its Member States to facilitate access to asylum in the EU and guarantee the human rights of all migrants; strongly condemns all readmission policies, especially those relating to countries such as Nigeria, under which people risk their lives and face ill-treatment contrary to the Geneva Convention; condemns the EU's financial support for policies whose aim is to externalise border controls without changing the current situation of people in need in the countries concerned; calls for the guaranteeing of rights and of a safe passage to both migrants and displaced people; stresses further that development aid must not be made conditional on cooperation in migration matters such as border management or readmission agreements; recalls its concerns over the increasing use of trust funds, such as limited transparency, lack
