

SUGGESTIONS

The Committee on Transport and Tourism calls on the Committee on Budgetary Control, as the committee responsible, to incorporate the following suggestions in its motion for a resolution:

- 1. Welcomes the finding of the Court of Auditors that the accounts of the European Maritime Safety Agency for the 2013 financial year are in order;
- 2. Notes that the Agency's annual budget for 2013 was EUR 57,8 million in commitment appropriations and EUR 54,03 million in payment appropriations, and that the implementation rates were 98 % and 95 % respectively;
- 3. Highlights the Agency's vital role as guarantor of maritime safety in Europe, with its competences having been expanded following the adoption of its new basic regulation in February 2013; stresses in this respect that the Agency has to be given the financial, material and human resources it needs to perform its tasks successfully;
- 4. Recalls that the Agency has agreed that the declarations of interest and CVs of the members of the Administrative Board, the Executive Director and the senior management should be publicly available;
- 5. Appreciates the fact that the Court of Auditors did not make any comments on the Agency's financial management in 2013; reminds the Agency to nevertheless continue to improve the reliability of accounting procedures and information in respect of costs for internally generated intangible assets;
- 6. Welcomes the fact that the Agency has drawn up guidelines for dealing with conflicts of interests and has begun to organise compulsory training for all employees in matters of ethics and integrity;
- 7. Proposes that Parliament grant the Executive Director of the European Maritime Safety Agency discharge in respect of the implementation of the Agency's budget for the financial year 2013.
