Annual report on the contracts awarded by the European Parliament

Contents

This document is the annual report to the budgetary authority on the contracts awarded by the European Parliament in 2008. In accordance with Article 54 of the Implementing Rules for the Financial Regulation (IR), it also includes contracts concluded on the basis of exceptional negotiated procedures referred to in Articles 126 and 127 of the IR.

Introduction

Regulatory provisions governing reporting

1. The Financial Regulation (FR) and its detailed Implementing Rules (IR), which came into force on 1 January 2003 and have since been modified¹, lay down the information to be provided to the budgetary authority, and to the public, concerning the award of contracts by the institution.
2. First, in accordance with Articles 54 and 119 of the IR (see Annex 1), the institution sends the budgetary authority (a) a report on the exceptional negotiated procedures launched on the basis of Articles 126 and 127, and (b) a list of building contracts and of contracts declared secret. In addition, in accordance with the resolution accompanying the decision concerning the discharge in respect of the implementation of the European Parliament's budget for 2001, the Secretary-General ensures that the Committee on Budgetary Control regularly receives full information on Parliament's contract award activities².
3. Secondly, pursuant to Article 90 of the FR and Article 119 of the IR (see Annex 1), the institution is responsible for publishing annually:
 - (a) in the Official Journal of the European Union (OJEU), lists of contractors in respect of contracts with a value greater than €60 000 and lower than the thresholds³ laid down in Directive 2004/18/EC (with the exception of service contracts coming under Annex IIB to the same Directive, in respect of which no upper limit applies);
 - (b) on the institution's website,
 - (i) a list of contractors in respect of contracts with a value of between €25 000 and €60 000;
 - (ii) a list of contractors awarded building contracts and of contracts declared secret;
 - (iii) since 2007, information on the value and contractors in respect of specific contracts based on a framework contract during the last reference year when the aggregate value of those specific contracts exceeds the thresholds laid down in the above-mentioned directive⁴.
4. In addition to the arrangements detailed above, and pursuant to paragraph 35 of the European Parliament's resolution of 23 April 2009 with observations on the discharge in respect of the implementation of the institution's budget for 2007⁵, a single and complete annual list of contracts awarded by the European Parliament with a value equal to or greater than €25 000 will be published from 2010 on the European Parliament's website.

Methodology

5. The annual report on contracts awarded by the European Parliament is drawn up by DG Finance on the basis of the information entered by the authorising departments into the *DataBase on Contracts and Grants (DBCG)* in respect of the contracts they have awarded which have a value equal to or greater than €25 000.
6. On 1 January 2008, in accordance with decisions taken by the Bureau of the European Parliament⁶, the names and structures of certain directorates-general were changed. As a result, the figures relating to exceptional negotiated procedures in 2007 have been adjusted in this report to make them easier to analyse and for comparability with 2008.
7. The information contained in this report summarises the main characteristics of the service, supply, works and building contracts with a value equal to or greater than €25 000 awarded by the European Parliament in 2008. The lists of contracts are appended hereto.

Contracts awarded: overall situation

8. All the European Parliament's directorates-general awarded contracts with a value equal to or greater than €25 000 in 2008. The combined value of those contracts was €682.2 m (€331.5 m in 2007). If low-value contracts, i.e. those with a value equal to or less than €60 000, are excluded, the total figure is €675.2 m (€326.3 m in 2007).

9. In 2008 the total value of the contracts awarded was greater than that in the previous year. The value of contracts awarded in 2008 was twice the value of the contracts awarded in 2007. However, the number of contracts awarded in 2008 was only 50% higher than in 2007.
10. Apart from certain expenditure related to preparations for the European elections, an analysis of the contracts awarded shows that the increase in 2008 (in the order of €350 m) was mainly due to the activities of three directorates-general:
 - DG Infrastructure and Logistics, whose transactions connected with the building sector, including certain works, recorded a rise of nearly €100 m compared to 2007, in addition

- to contracts involving the renewal of multi-annual framework contracts with an approximate value of €50 m;
- DG Translation, which recorded an increase of more than €135 m compared to 2007 as a result of the renewal of multi-annual framework contracts for translations into the 23 official languages, as well as maintaining the translation of the verbatim reports;
 - DG Innovation and Technological Support, which awarded contracts in 2008 worth more than €50 m.

11. In 2008, 214 contracts with a value equal to or greater than €60 000 were awarded, and 144 with a value of between €25 000 and €60 000. These figures show that contracts with a value of less than €60 000 accounted for only 1.03% of the total value, but for 40.22% of the total number, of all types of contract awarded by the European Parliament. These proportions are similar to those recorded in 2007.

Types of contract awarded

12. The breakdown of all contracts awarded in 2008 and 2007, including building contracts, is as follows:

13. In 2008, as in 2007, service contracts were the most significant in terms of both number and value, followed by building contracts.

Building contracts

14. 2008 was characterised by a very slight increase in the number and, at the same time, a bigger increase in the value of the building contracts awarded by comparison with the previous year. In 2008 fifteen building contracts were awarded with a total value of €123.4 m (see Annex 4). They concerned primarily the renewal of the lease for Tower B, the lease of the President Building, the concluding of a lease conferring right in rem for the Eastman Building, the purchase of information offices in Vienna and London and the subletting of areas for using ICT infrastructure in the Resilience Centre Building.
15. The building contracts referred to above were awarded by negotiated procedure, as is the norm for this type of contract.

Service contracts

16. Sixty-two service contracts were awarded with a value equal to or greater than €1 m, totalling € 434.2 m, or 95.5% of the total value of such contracts. Forty-two of those contracts were awarded by the Directorate-General for Translation as renewals of various framework contracts, 22 of which were inter-institutional.
17. In 2008 authorising officers used an open or restricted procedure to award service contracts totalling €397.7 m, or 87.47% of the total value of such contracts.

Supply contracts

18. Supply contracts accounted for 3% of the total value of the contracts awarded in 2008, compared with 13% in 2007. Only eight supply contracts had a value equal to or greater than €1 m, totalling €17 m, or 74.5% of the total value of such contracts.

Works contracts

19. Forty-four works contracts were awarded in 2008, which is significantly more than the previous year. The five main works contracts accounted for 59% of the total value of such contracts, while the contract for the extension and renovation of the KAD building alone accounted for 25.8%.

Procedures used

20. The breakdown of contracts awarded in 2008 and 2007 by type of procedure used is as follows:

21. Of a total of 358 contracts awarded in 2008, 140 were based on open or restricted procedures, with a value of €485.2 m, and 218 on negotiated procedures, with a total value of €197 m.
22. Exceptional negotiated procedures launched in accordance with Article 126(1)(a) to (g) and Article 127(1)(a) to (d) of the IR accounted for a little over one-third of the number of negotiated procedures launched in 2008. A more detailed report on these contracts is given below, beginning at paragraph 31.

23. In 2008, in terms of the number of contracts, the open procedure was used considerably more often than in 2007 (an increase of nearly 50%, from 85 in 2007 to 126 in 2008). Use of the restricted procedure also increased slightly in terms of the number of contracts, but remained relatively unchanged as a proportion of the total number of contracts awarded.

Open invitations to tender

24. The open tender procedure allows any legal or natural person to submit a tender. All contracts with a value equal to or greater than the thresholds laid down by the public procurement directive are automatically subject to this type of procedure (or to a restricted procedure following publication of a notice in the OJEU). However, there is nothing to prevent contracting departments from using this type of procedure for contracts with a value below the statutory thresholds. It is worth noting that in 2008 the European Parliament awarded 36 contracts below those thresholds by open procedure (25 in 2007), when a less demanding procedure could have been used.
25. In 2008 the European Parliament awarded a total of 126 contracts (85 in 2007), with an aggregate value of €345.4 m (€162.1 m in 2007), by open procedure.

Restricted invitations to tender

26. A contract award procedure is restricted when only candidates who meet the selection criteria are invited by the contracting authorities simultaneously, and in writing, to submit a tender. In some cases the candidates invited to submit a tender may be selected from a list drawn up following a call for expressions of interest (CEI). The rules provide for the use of such a list for all contracts with a value greater than €60 000 and lower than the thresholds in the directive. The number of candidates invited to submit a tender in a restricted procedure may not be less than five, provided that a sufficient number of candidates meet the selection criteria. At all events, the number of candidates permitted to submit a tender must be sufficient to ensure genuine competition.
27. In 2008 the European Parliament awarded a total of 14 contracts (12 of which had a value greater than €60 000), with an aggregate value of €139.7 m, by restricted procedure.

Negotiated procedures

28. In a negotiated procedure the contracting authorities contact the tenderers of their choice who meet the selection criteria, which have already been established and announced, and negotiate the terms and conditions of the contract with one or more of them. In most cases, the number of candidates invited to negotiate may not be less than three, provided that a sufficient number of candidates meet the selection criteria. In all cases, the number of candidates permitted to submit a tender must be sufficient to ensure genuine competition.
29. Earlier rules, although aimed at enhancing competition, were found to be counterproductive insofar as only the largest firms proved able to comply with all the procedural requirements. Consequently, and at Parliament's initiative, the rules were eased in 2007. Among other changes, the ceiling for 'low-value' contracts, for which negotiated procedures are the norm rather than the exception, was raised to €60 000.

30. The use of a negotiated procedure to award a contract with a value greater than €60 000 invariably constitutes an exception to the general rule. Exceptions are governed by Articles 126 and 127 of the IR. In 2008 a total of 63 contracts with a unit value greater than €60 000 were awarded on the basis of negotiated procedures.
31. The breakdown of contracts awarded in 2008 and 2007, by type of negotiated procedure used, is as follows:

Report on exceptional negotiated procedures

32. Pursuant to the provisions of Article 54 of the IR, authorising officers by delegation record, for each financial year, contracts concluded by negotiated procedure on the basis of Article 126(1)(a) to (g), Article 127(1)(a) to (d) and Articles 242, 244 and 246. If the proportion of negotiated procedures in relation to the number of contracts awarded by the same authorising officer by delegation increases appreciably in relation to earlier years or if that proportion is distinctly higher than the average recorded for the institution, the authorising

officer responsible must report this to the institution, setting out any measures taken to reverse that trend. Each institution forwards a report on negotiated procedures to the budgetary authority.

33. This report highlights the changes from 2007 to 2008 in respect of all contracts with a value equal to or greater than €25 000 concluded by negotiated procedure pursuant to Article 126(1)(a) to (g) and Article 127 (1)(a) to (d) of the IR.
34. The following table shows the trend, by directorate-general and for the institution as a whole, in the use of negotiated procedures in terms of the number and value of contracts awarded. In view of the reorganisation of certain directorates-general at the start of 2008, and in order to make the comparison required by Article 54 of the IR possible, the information concerning 2007 has been adjusted to take account of the new names and structures of the directorates-general concerned.

35. Annex 3 lists the contracts awarded by exceptional negotiated procedure in 2008, together with the relevant legal basis given by the authorising officers for using that procedure.
36. There was an increase of approximately 5% in the use of exceptional negotiated procedures by the institution as a whole in 2008 compared with 2007 (up from 16.87% in 2007 to 22.35% in 2008).
37. By comparison with 2007 it can be seen that the proportion of exceptional negotiated procedures increased in terms of the total number of contracts in the case of six authorising

officers by delegation. The other authorising officers by delegation either continued to make no use of this type of procedure or reduced its use.

38. Where they do make use of negotiated procedures, authorising officers by delegation justify this by choices associated with mostly technical imperatives: ownership of a licence or patent, supplementary works and/or services required because the request for services has been modified, or to cope with unforeseen circumstances on a work site, overriding urgency, purchase of furniture or equipment compatible with existing furniture, or servicing and repairs to be carried out by the manufacturer of existing equipment.
39. Insofar as some of the examples listed in the preceding paragraph are inherent to the areas of activity concerned, it is difficult to reduce further the use of negotiated procedures. On the other hand, as the use of exceptional negotiated procedures was in some cases due to unforeseen circumstances (such as the collapse of the ceiling in the Strasbourg chamber), less use of such procedures can be expected in future.

Annex 1: Regulatory provisions governing the advertising of contracts and information for the budgetary authority

Article 90 of the Financial Regulation

1. All contracts exceeding the thresholds provided for in article 105 or article 167 shall be published in the Official Journal of the European Union.

Contract notices shall be published in advance except in the cases referred to in article 91(2) of this Regulation, as specified in the implementing rules, and for the service contracts covered by Annex IIB to Directive 2004/18/EC of the European Parliament and of the Council of 31 March 2004 on the coordination of procedures for the award of public works contracts, public supply contracts and public service contracts¹.referred to in the implementing rules.

Publication of certain information after the contract has been awarded may be dropped where it would hinder application of the law, would be contrary to the public interest or would harm the legitimate business interests of public or private undertakings or could distort fair competition between them.

2. Contracts with a value below the thresholds provided for in article 105 or article 167 and the service contracts referred to in Annex IIB to Directive 2004/18/EC shall be advertised by appropriate means, as specified in the implementing rules.

Article 118 of the Implementing Rules

Advertising of contracts covered by Directive 2004/18/EC, with the exception of contracts referred to in Annex IIB thereto

1. Publication for contracts with a value equal to or above the thresholds laid down in Articles 157 and 158 shall consist in a pre-information notice, a contract notice or simplified contract notice and an award notice.

2. The pre-information notice is the notice by which the contracting authorities make known, by way of indication, the estimated total value of contracts and framework contracts, by category of service or groups of products, and the essential characteristics of works contracts which they intend to award during a budgetary year, but excluding contracts under the negotiated procedure without prior publication of a contract notice. The pre-information notice shall be compulsory only where the estimated total value of the contracts is equal to or above the thresholds laid down in Article 157 and the contracting authority intends to make use of the possibility of shortening time limits for receipt of tenders in accordance with Article 140(4).

The pre-information notice shall be published either by the Office for Official Publications of the European Communities (OPOCE) or by the contracting authorities themselves on their buyer profile as referred to in point (2)(b) of Annex VIII to Directive 2004/18/EC.

The pre-information notice shall be sent to OPOCE or published on the buyer profile as soon as possible and in any event by no later than 31 March of each budgetary year in the case of supply and service contracts and, in the case of works contracts, as soon as possible after the decision approving the programme for those contracts.

Contracting authorities which publish the pre-information notice on their buyer profile shall send to OPOCE, electronically and using the format and transmission procedures specified in point 3 of Annex VIII to Directive 2004/18/EC, a notice announcing the publication of a pre-information notice on a buyer profile.

3. The contract notice is the means by which the contracting authorities make known their intention to launch a procedure for the award of a contract or framework contract or to set up a dynamic purchasing system in accordance with Article 125a. Without prejudice to contracts concluded after a negotiated procedure as referred to in Article 126, the contract notice shall be compulsory for the following contracts:

- (a) contracts with an estimated value equal to or above the thresholds laid down in points (a) and (c) of Article 158(1);
- (b) research and development contracts listed in category 8 of Annex II A with an estimated value of equal to or above the threshold laid down in point (b) of Article 158(1) for research and development contracts listed.

It shall not be compulsory for specific contracts based on framework contracts.

Contracting authorities which wish to award a specific contract based on a dynamic purchasing system shall make known their intention by means of a simplified contract notice.

In an open procedure the contract notice shall specify the date, time and, where appropriate, place of the meeting of the opening committee, which shall be open to the tenderers.

Contracting authorities shall state whether or not they authorise variants and shall specify the minimum capacity levels they demand if they make use of the possibility provided for in the second subparagraph of Article 135(2). They shall set out the selection criteria referred to in Article 135 that they intend to use, the minimum number of candidates they plan to invite to tender and, where appropriate, the maximum number, and the objective and non-discriminatory criteria they intend to apply in order to limit the number, in accordance with the second subparagraph of Article 123(1).

Where there is unrestricted, direct and full access to the call for tenders by electronic means, in particular in the dynamic purchasing systems referred to in Article 125a, the Internet address at which these documents can be consulted shall appear in the contract notice.

Contracting authorities wishing to organise a contest shall issue a notice announcing their intention.

Whenever appropriate, contracting authorities shall specify in the contract notice that the procurement procedure is an inter-institutional procurement procedure. In such cases, the contract notice shall indicate the institutions, executive agencies or bodies referred to in Article 185 of the Financial Regulation which are involved in the procurement procedure, the institution responsible for the procurement procedure and the global volume of the contracts for all those institutions, executive agencies or bodies.

4. The award notice shall give the outcome of the procedure for the award of contracts, framework contracts or contracts based on a dynamic purchasing system. In the case of contracts with a value equal to or above the thresholds laid down in Article 158, the award notice shall be compulsory. It shall not be compulsory for specific contracts based on framework contracts.

The award notice shall be sent to the OPOCEno later than forty-eight calendar days after the procedure is closed, that is to say, from the date on which the contract or framework contract is signed. However, notices relating to contracts based on a dynamic purchasing system may be grouped together on a quarterly basis. In such cases, they shall be sent to the OPOCE no later than forty-eight days after the end of each quarter.

The award notice shall also be sent to the OPOCE in the case of a contract or a framework contract with a value equal or above the thresholds laid down in Article 158 and awarded pursuant to a negotiated procedure without prior publication of a contract notice, in sufficient time for the publication to occur before the signature of the contract, in accordance with the terms and conditions provided in Article 158a, paragraph 1.

Information relating to the value and contractors of specific contracts based on a framework contract during a financial year shall be published on the internet website of the contracting authority no later

than 31 March following the end of this financial year, if as a result of the conclusion of a specific contract or of the aggregate volume of the specific contracts the thresholds referred to in Article 158 are exceeded.

Contracting authorities which have held a design contest shall send the OPOCE a notice of the results of the contest.

5. The notices shall be drawn up in accordance with the standard forms adopted by the Commission pursuant to Directive 2004/18/EC.

Article 119 of the Implementing Rules

Advertising of contracts not covered by Directive 2004/18/EC, and of the contracts referred to in Annex IIB thereto

1. Contracts with a value below the thresholds laid down in Article 158 and the service contracts referred to in Annex IIB to Directive 2004/18/50/EC shall be advertised by appropriate means in order to ensure competitive tendering and impartiality of the procurement procedure. Such advertising shall involve:

(a) if no contract notice as referred to in Article 118(3) has been published, notice of a call for expressions of interest for contracts covering a similar subject with a value greater than the amount referred to in Article 128(1);

(b) the annual publication of a list of contractors, specifying the subject and the value of the contract awarded, for contracts with a value greater than EUR 25000.

2. A list of contractors to whom building contracts and contracts declared secret in accordance with Article 126(1)(j) are awarded shall be published only once a year, with an indication of the subject and value of the contracts awarded. That list shall be sent to the budgetary authority. In the case of the Commission, it shall be annexed to the summary of the annual activity reports referred to in Article 60(7) of the Financial Regulation.

3. Information relating to contracts with a value equal to or greater than the amount referred to in Article 128(1) shall be sent to the Office for Official Publications of the European Communities; the annual lists of contractors shall be sent by no later than 31 March following the end of the financial year.

Ex ante advertising and the annual publication of the list of contractors for the other contracts shall be on the Internet site of the institutions; ex post publication shall take place by no later than 31 March of the following financial year. Publication may also be in the Official Journal of the European Communities.

Article 54 of the Implementing Rules

Report on negotiated procedures

Authorising officers by delegation shall record, for each financial year, contracts concluded under the negotiated procedures referred to in Articles 126(1)(a) to (g), 127(1)(a) to (d), 242, 244 and 246. If the proportion of negotiated procedures in relation to the number of contracts awarded by the same authorising officer by delegation increases appreciably in relation to earlier years or if that proportion is distinctly higher than the average recorded for the institution, the authorising officer responsible shall report to the institution setting out any measures taken to reverse that trend. Each institution shall send a report on negotiated procedures to the budgetary authority. In the case of the Commission, that report shall be annexed to the summary of the annual activity reports referred to in Article 60(7) of the Financial Regulation.

Annex 3: Regulatory provisions governing exceptional negotiated procedures (Articles 126 and 127 of the Implementing Rules of the Financial Regulation)

Article 126

Use of a negotiated procedure without prior publication of a contract notice (Article 91 of the Financial Regulation)

1. Contracting authorities may use the negotiated procedure without prior publication of a contract notice, whatever the estimated value of the contract, in the following cases:

- (a) where no tenders or no suitable tenders, or no applications have been submitted in response to an open procedure or restricted procedure after the initial procedure has been completed, provided that the original terms of the contract as specified in the call for tenders referred to in Article 130 are not substantially altered;
- (b) where, for technical or artistic reasons, or for reasons connected with the protection of exclusive rights, the contract can be awarded only to a particular economic operator;
- (c) in so far as is strictly necessary where, for reasons of extreme urgency brought about by unforeseeable events not attributable to the contracting authorities, it is impossible to comply with the time-limits set for the other procedures and laid down in Articles 140, 141 and 142;
- (d) where a service contract follows a contest and must, under the rules applying, be awarded to the successful candidate or to one of the successful candidates; in the latter case, all successful candidates shall be invited to participate in the negotiations;
- (e) for additional services and works not included in the project initially envisaged or in the initial contract but which, through unforeseen circumstances, have become necessary for the performance of the services or works, subject to the conditions set out in paragraph 2;
- (f) for new services or works consisting in the repetition of similar services or works entrusted to the economic operator awarded the initial contract by the same contracting authority, provided that these services or works conform to a basic project and that this project was the subject of an initial contract awarded under the open or restricted procedure, subject to the conditions set out in paragraph 3;
- (g) for supply contracts:
 - (i) in the case of additional deliveries which are intended either as a partial replacement of normal supplies or installations or as the extension of existing supplies or installations, where a change of supplier would oblige the contracting authority to acquire equipment having different technical characteristics which would result in incompatibility or disproportionate technical difficulties in operation and maintenance; the length of such contracts may not exceed three years;
 - (ii) where the products are manufactured purely for the purpose of research, experiment, study or development, with the exception of commercial viability tests and large-scale production aimed at recovering research and development costs;
 - (iii) in respect of supplies quoted and purchased on a commodity market;
 - (iv) in respect of purchases on particularly advantageous terms, either from a supplier which is definitively winding up its business activities, or from the receivers or liquidators of a bankruptcy, an arrangement with creditors, or a similar procedure under national law;

- (h) for building contracts, after prospecting the local market;
- (i) for contracts for legal services within the meaning of Annex IIB to Directive 2004/18/EC; provided that such contracts are appropriately advertised;
- (j) for contracts declared to be secret by the institution or by the authorities delegated by the institution, or for contracts whose performance must be accompanied by special security measures, in accordance with the administrative provisions in force or when the protection of the essential interests of the Communities or of the Union so requires.

Contracting authorities may also use the negotiated procedure without prior publication of a contract notice in the case of contracts with a value less than or equal to EUR 60000.

2. For the additional services and works referred to in point (e) of paragraph 1, the contracting authority may make use of the negotiated procedure without prior publication of a contract notice on condition that the award is made to the contractor performing the contract:

- (a) where such additional contracts cannot be technically or economically separated from the main contract without serious inconvenience for the contracting authority; or
- (b) where such services or works, although separable from the performance of the original contract, are strictly necessary for its completion.

The aggregate value of additional contracts may not exceed 50% of the amount of the initial contract.

3. In the cases referred to in point (f) of the first subparagraph of paragraph 1, the option of using the negotiated procedure shall be pointed out as soon as the first operation is put out to competitive tender, and the total estimated amount for the subsequent services or work shall be taken into consideration in calculating the thresholds referred to in Article 158. That procedure may be used only during the three years following conclusion of the original contract.

Article 127
Use of a negotiated procedure after prior publication of a contract notice
(Article 91 of the Financial Regulation)

1. Contracting authorities may use the negotiated procedure after having published a contract notice, whatever the estimated value of the contract, in the following cases:

- (a) where tenders which are irregular or unacceptable, by reference in particular to the selection or award criteria, are submitted in response to an open or restricted procedure, or a competitive dialogue, which has been completed, provided that the original terms of the contract as specified in the call for tenders referred to in Article 130 are not substantially altered, without prejudice to the application of paragraph 2;
- (b) in exceptional cases involving work, supplies or services where the nature or the risks do not permit prior overall pricing by the tenderer;
- (c) where the nature of the service to be procured, in particular in the case of financial services and intellectual services, is such that contract specifications cannot be established with sufficient precision to permit the award of the contract by selecting the best tender in accordance with the rules governing open or restricted procedures;
- (d) for works contracts, where the works are performed solely for purposes of research, testing or development and not with the aim of ensuring profitability or recovering research and development costs;

- (e) for the service contracts referred to in Annex IIB to Directive 2004/18/EC, subject to points (i) and (j) of the first subparagraph of Article 126(1) of this Regulation and the second subparagraph thereof.
- (f) for research and development services other than those where the benefits accrue exclusively to the contracting authority for its use in the conduct of its own affairs, on condition that the service provided is wholly remunerated by the contracting authority;
- (g) for service contracts for the acquisition, development, production or co-production of programme material intended for broadcasting by broadcasters and contracts for broadcasting time.

2. In the cases referred to in point (a) of paragraph 1, contracting authorities may refrain from publishing a contract notice if they include in the negotiated procedure all the tenderers and only the tenderers satisfying the selection criteria who, during the previous procedure, submitted tenders in accordance with the formal requirements of the procurement procedure.
