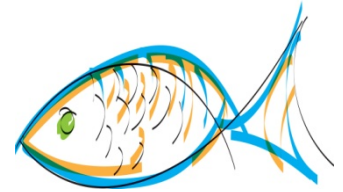

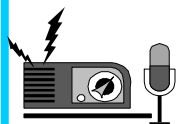

#### **EP will not seek a court decision on the EU-Morocco fisheries agreement**

29/09/2011

A bid by 77 MEPs to have the new protocol to the EU-Morocco fisheries agreement referred to the European Court of Justice (ECJ), for a ruling on whether it is fair to the people of Western Sahara, was halted by a plenary vote in Parliament on Thursday.

The resolution calling for the ECJ ruling was rejected in the plenary vote (221 in favour, 302 against and 30 abstentions).

The bid's backers argued that a European Court of Justice (ECJ) ruling would dispel legal uncertainty as to whether the inclusion of the Western Sahara in the protocol reflects the wishes of the local population and whether it takes their interests into account, as required by EU treaties and international law.

#### **What's next?**

The process of approving the controversial protocol will now continue in committee. The Fisheries Committee vote is scheduled for its November meeting (22 - 23 November). The final vote in plenary should take place in December.

#### **The EU pleased with NAFO's continued commitment to the conservation of international fish stocks and the protection of Atlantic ecosystems**

Thanks to the continued commitment of the European Union to follow scientific advice and its close cooperation with partner countries, the Northwest Atlantic Fisheries Organisation (NAFO) adopted science-based, precautionary measures for the conservation and management of its fish stocks and ecosystems at its Annual Meeting held in Halifax, Canada, on 19-23 September 2011.

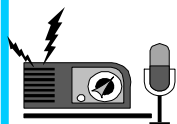
NAFO set total allowable catches (TACs) for a number of its stocks under its purview, including cod and redfish in the Flemish Cap strictly in line with the scientific advice, at 9280 tonnes and 6500 tonnes respectively.

Unfortunately for the third important stock on the Flemish Cap – shrimp – NAFO was unable to reopen the fishery closed last year due to enduring bad condition of the stock.

Likewise, the continuing downward trend for the shrimp stock in the Grand Banks led NAFO to significantly decrease fishing opportunities from 19200 tonnes in 2011 to 12000 tonnes in 2012 and 9350 tonnes in 2013.

NAFO was able to reap the benefits of the work carried out in the previous years – as a result of the adoption of a ground-breaking management procedure for one of its most important stocks – Greenland Halibut – last year, the TAC for 2012 was set at 16382 tonnes in accordance with the rule.

NAFO also formally adopted Conservation Strategies and Rebuilding Plans developed earlier this year for two of its stocks under moratoria – Grand Banks cod and American

...Plaice in order to accelerate their recovery and agreed to continue this valuable work for other species under a fishing ban.

In line with its Action Plan for the protection of elasmobranchs (sharks, rays and skates), the EU worked with NAFO Contracting Parties to lower the TAC for thorny skates for conservation of these vulnerable species.

The EU was instrumental in ensuring that NAFO took further action on the protection of Vulnerable Marine Ecosystems from the significant adverse impacts of bottom fisheries by tabling a proposal (co-sponsored by Canada) for an extension of the closed area 5 (Flemish Cap Northeast Prong) in order to protect the most interesting arrangement of corals and sponges communities identified so far in the NAFO Area. The EU also co-sponsored a US proposal to conduct a reassessment of the impact of NAFO bottom fisheries on Vulnerable Marine Ecosystems by 2016 and every five years thereafter.

Most importantly, NAFO lowered the threshold for sponge indicator species which trigger reporting obligations and well as a move-away rule in the existing fishing areas (with a temporary closure in new fishing areas) to 600 kg (down from 800kg) for existing fishing areas and 400kg (down from 800kg) for new fishing areas. This decision promises to bring more information about encounters of Vulnerable Marine Ecosystems in NAFO waters to the NAFO Scientific Council for further action on their protection in the future. The EU hopes that other Regional Fisheries Management Organisations will be able to follow suit.

NAFO also agreed to extend the closures of its sponge and coral protection zones to 2014, when more information from the scientific project NEREIDA is due to become available.

NAFO committed to work inter-sessionally to develop a concrete course of action to implement the recommendations of the

Performance Review (PR) carried out earlier this year. Moreover, upon EU's leadership, NAFO took important steps for increased transparency already at this meeting, in line with the PR panel recommendations.

The EU regrets however that the NAFO Contracting Parties were not in a position to act on another of Performance Review recommendations and adopt the EU/US proposal for a resolution concerning climate change and its potential effects on NAFO fishery resources.

The European Commission is convinced that the measures adopted by NAFO at this Annual Meeting will yield long term environmental and socio-economic benefits ensuring good condition of the fish stocks and the ecosystem and an economic viability for NAFO fishermen.

### Background

The Northwest Atlantic Fisheries Organisation (NAFO) was established in 1979, with the objective of contributing to the optimum utilisation, rational management and conservation of the fishery resources of the Convention Area. Its current Contracting Parties are Canada, Cuba, Denmark (in respect of the Faroe Islands and Greenland), the European Union, France (in respect of St. Pierre et Miquelon), Iceland, Japan, Republic of Korea, Norway, Russia, Ukraine and the United States of America.



### **Fisheries: Commission proposes fishing opportunities for 2012 for EU fish stocks in the Atlantic and North Sea**

27/09/2011

The European Commission presented today its first proposal for 2012 fishing opportunities for certain stocks in the Atlantic and the North

Sea. Today's proposal sets levels of total allowable catch (TAC) and fishing effort for the fish stocks managed by the EU exclusively, and not for stocks managed with third countries. Based on scientific advice, the Commission proposes to increase the TAC for 9 stocks (certain stocks of cod, anglerfish, herring, haddock, hake, sole, megrim and Norway lobster) and reduce it for 53 stocks. For cod in the West of Scotland, the Irish Sea and the Kattegat, the Commission proposes that no fishing takes place in 2012, given the poor state of these stocks. The proposed changes would amount to an overall reduction in TACs (by weight) of 11% compared to 2011. The Commission's goal is to set TACs at science-based levels which help recover the stocks and make fisheries sustainable in the long term.

Maria Damanaki, Commissioner for Maritime Affairs and Fisheries, said: "our proposal's cornerstones are long-term management of stocks and reliable scientific data to base our decisions on, in line with our proposed reform of the Common Fisheries Policy. This reform will deliver a fisheries policy fit for the future, based on viable fish stocks which will assure fishermen a decent income."

The proposed catch limits are based on the scientific advice from the International Council for the Exploration of the Sea (ICES) and the Scientific, Technical and Economic Committee for Fisheries (STECF). Stakeholders were also consulted on the basis of the Commission's Consultation document from May (IP/11/638).

The Commission's ultimate aim is that all stocks are fished at sustainable levels, the so-called Maximum Sustainable Yield (MSY), by 2015 – a commitment that the EU made to the international community, and which is also a key pillar of the proposed CFP reform.

To help achieve MSY by 2015, the International Council for the Exploration of

the Sea (ICES) has started to frame its scientific advice with this goal in mind, whenever possible. Also, multi-annual management plans are being put in place for all major commercial stocks. Stocks managed in this way tend to fare better than those subject to short-term decision-making.

### Background

The present proposal concerns only the 83 stocks for which the TACs are decided by the EU alone, and is scheduled to be discussed by the member states' fisheries ministers at the November Fisheries Council.

A second proposal will deal with the 66 stocks for which the fishing opportunities must be agreed with Regional Fisheries Management Organisations (RFMOs) or in the context of consultations with third countries and will be tabled later this autumn. Thanks to splitting the proposal in this way, fishermen will learn sooner how much they can fish in 2012 and be able to plan ahead better.

For some stocks the long-term approach has already proven beneficial. For example the stocks of anglerfish in North and North-West Spain may reach sustainable levels (MSY) already in 2012, even with higher catches (110% increase in TAC proposed), and the TACs for cod in the Celtic Sea and the Bay of Biscay can be safely increased by 141%.

But serious concerns for a number of stocks remain. In particular, due to poor state of the stocks, the Commission proposes to stop fishing for cod in the West of Scotland, the Irish Sea and the Kattegat. Poor data hampers the management of these stocks and despite successive cuts in the TACs over the recent years, the stocks still fail to recover.

For stocks where data are too poor to properly estimate their size, the Commission applied a so-called precautionary principle,

reducing the TACs by between 15% and 25% until more reliable data are available.

For 12 stocks the scientific advice will be issued in the autumn, so the proposal contains no figures for them at the moment.

The Commission already proposed fishing opportunities for the Baltic Sea for 2012 on 15 September (IP/11/1033). These proposals will be discussed by ministers at the October Fisheries Council.



### **Commission seeks Italy's compliance with Court ruling on illegal use of drift-nets in the Mediterranean**

The European Commission calls on Italy to take measures and comply with an October 2009 Court of Justice ruling on Italy's continued illegal use of drift-nets. The Court found that Italy had failed to adequately control and enforce the EU ban on the use of drift-nets. Safeguarding of fish stocks and the eradication of illegal fishing practices are crucial priorities for the EU, and the Commission, in particular Commissioner for Maritime Affairs and Fisheries, Maria Damanaki, deeply regrets Italy's long-standing infringement of the drift-net ban, which dates from 1992. If no satisfactory actions are taken within two months from the receipt of the Commission's letter, the Commission may refer this case to the Court of Justice again, this time asking the Court to impose significant financial penalties on Italy in accordance with the Treaty rules.

Fishing with illegal gear such as drift-nets is highly destructive, as it ruins marine habitats, endangers marine wildlife and threatens sustainable fisheries. Illegal fishing practices ruin the income of honest fishermen and



coastal communities - and the future of fisheries altogether. Therefore, in the interest of all, implementation and enforcement of the rules are at the heart of the Commission priorities.

Despite persistent calls on Italy to fulfil its monitoring and enforcement tasks adequately with regard to illegal drift-nets, recent on-site inspections did not show any significant improvements as compared to the situation before the Court's judgement. The Commission's verifications indicate that drift-nets are still used illegally in Italy in large numbers, and that actions taken by national authorities are neither sufficient, nor efficient enough to deter their use.

### **Background**

The origins of this case go back to 1992, when the EU adopted the drift-net ban prohibiting the use of drift-nets of over 2,5 km in length (in response to a 1991 UN General Assembly moratorium on large pelagic drift-nets).

Since then, the EU has constantly toughened its anti-drift-net rules to address growing concerns about this fishing technique, which is highly non-selective (high degree of by-catches of non-targeted species) and therefore poses a threat to the conservation of many fish stocks, and marine mammals. As from January 2002, the EU has completely banned the use of drift-nets, irrespective of their length, intended for the capture of certain fish stocks, such as albacore, bluefin tuna and swordfish.

### **Renewal of fisheries agreement EU/Guinea Bissau**

The European Commission has today adopted formal proposals for a new one-year protocol to the fisheries agreement with Guinea Bissau, agreed by the two parties on 16 June 2011.

This protocol maintains the conditions of the current one, i.e. fishing possibilities for 4,400 gross register tonnage (GRT) for shrimp trawlers, 4,400 GRT for fin-fish and cephalopod trawlers, 23 tuna seiners and longliners, and 14 pole-and-line vessels. The EU financial counterpart amounts to 4,550,000 € for the right to fish and 2,950,000 € for the support of the fisheries sector in Guinea Bissau. A new clause was added to allow for the suspension of the protocol if there is a breach of human rights and democratic principles. This fisheries agreement allows vessels mainly from Spain, Portugal, Italy, Greece and France to fish in the Guinea-Bissau waters. The one year extension of the protocol was agreed to give both parties the time necessary to assess the prospect of a future protocol of a longer duration.
