European Fisheries Fund: MEPs approve special funding for crisis-stricken states

The EU could pay up to 85% for projects focused on sustainable development of fisheries in Greece, Ireland, Portugal, Hungary, Latvia and Romania to help spur their economic recovery. Parliament approved on Wednesday temporary increase, until the end of 2013, in co-financing rates of the European Fisheries Fund for states in financial difficulty.

MEPs supported increase in co-financing rates of the European Fisheries Fund (EFF) by 10% to ensure countries facing liquidity problems caused by current economic and financial crisis, which is hitting their growth prospect and drying up public finances, can continue to implement their projects on the ground.

"The economic and financial crisis has had different effects in different Member States. Countries with weaker economies which have more needs for EU funding are very often those who have difficulties with accessing funds. This initiative has been necessary for a long time", said rapporteur of the regulation João Ferreira (GUE/NGL, PT) emphasising importance of adopted measures but pointing out that they come "regrettably late".

Temporary increase ...

New rules will be limited to the period for which the Member States in question are eligible for EU assistance under the European Financial Stabilisation Mechanism (for euro states) or the Balance of Payments Mechanism (for non-euro states) and will apply retroactively. Ireland, Greece and Portugal will thus be eligible for higher cofinancing rates from the day when the financial assistance under the EFSM was made available to them, while in case of Hungary, Latvia and Romania new rules will

apply from 1 January 2010.

Increased co-financing rates will only be available until the end of 2013 and will have no impact on the 2014-2020 programming period, stressed MEPs.

... under clear conditions

Parliament insists that the temporary rise in the EU's share of investment costs must be duly justified and should contribute to the promotion of growth, competitiveness and employment. Appropriate reporting should be ensured to this end, say MEPs.

New legislation does not increase overall amount of EU money earmarked for the EFF. Therefore, to obtain higher co-financing rates, Member States concerned need to prioritise projects. In addition, they will have to show that under the current maximum co-financing rates, they could not have afforded to pay their share of the projects.

New rules were approved with 617 votes in favour, 19 against and nine abstentions.

Registration for European Maritime Day 2012 is now open!

European Maritime Day 2012 will be organised in Gothenburg, Västra Götaland, Sweden on May 21 and 22, 2012. It is the first time Maritime Day is organised in Scandinavia and in the North Sea area.

The conference is co-organised by the European Commission, the Swedish Ministry of Enterprise, the Region Västra Götaland, and the City of Gothenburg. It will take place at Eriksbergshallen, a reconstructed old shipyard building at the water's edge featuring innovative architecture and striking Scandinavian design.



What is European Maritime Day?

European Maritime Day is celebrated annually on 20 May since 2008. It was established by a tripartite declaration signed between the European Commission, the European Parliament and the Council.

European Maritime Day is first and foremost a celebration of Europe's maritime community. The seas and oceans, and the opportunities they offer, are at the heart of discussions. It is also a great working environment where thoughts can be exchanged, experiences can be shared and new concepts and strategies can be devised. So far, the European Maritime Day has been hosted in Brussels, Rome, Gijon and Gdansk.

2012 edition: Blue Growth

In Gothenburg, the Conference of the EMD will focus on "Sustainable growth from oceans, seas and coasts: Blue Growth". Blue Growth is the EU's strategy to boost growth and jobs in the maritime and coastal economy. In line with the goals of the Europe 2020 strategy, Blue Growth is about helping Europe's maritime sectors be competitive and prosperous.

The global economic crisis affects coastal regions and maritime sectors deeply. In Gothenburg, Commissioner Damanaki and other high level speakers, including Swedish Ministers, the Secretary General of the IMO (International Maritime Organization), Members of Parliament, chief executive officers and experts, will strive to find solutions to foster new opportunities for businesses and for an economic environment that will contribute to a positive change in the sector.

European Maritime Day 2012 will also be the theatre for the official signature of the European Social Partners' Agreement on the ILO Convention 188 concerning work in the fishing sector. Commissioner Damanaki and Commissioner Andor (tbc) will attend the

ceremony of the signature of the agreement with the European social partners of the seafishing sector, Europeche and ETF (European Transport Workers' Federation).

Commission adopts quota deduction guidelines

Press release - 9/3/2012

Today, the European Commission has adopted the detailed rules for deduction of fishing quotas of Member states who have overfished their quotas.

Fishing quotas for each member state are set on an annual basis by the Council of Ministers. If a member state exceeds its annual quota for a certain stock, i.e. overfishes its quota, the Commission, in line with the 2009 Fisheries Control Regulation, must take action to correct this situation in the following year(s).

The guidelines set out how this should be done in practice. As a general rule, the Commission should recover the overfished amounts as quickly as possible, preferable in the following year, except in very specific cases. For the cases where no quota is allocated in the year following the overfishing for the concerned stock deductions are to be operated on other stocks. In such cases, the Commission will first operate the deductions on stocks fished by the fleet that overfished.

By setting these <u>guidelines</u> (to be used for 2012 as well as for the coming years) the Commission wants to ensure that the deductions are operated in a transparent and comprehensive way and in conformity with the principle of equal treatment.



The European Fisheries Control Agency (EFCA) adopts its Annual Report for 2011

The EFCA has adopted its annual report for 2011 at the meeting of the Administrative Board held on 15 of March.

The annual report highlighted all the activities undertaken by the EFCA during that year. The meeting took place following a seminar on the five year independent external evaluation of the EFCA which conclusions have helped the Board in the issuing of recommendations to the European Commission.

This General Report has been adopted in the context of the ongoing CFP reform in the year in which the Council and the European Parliament will have their say in the legislative proposal of the Commission. In this framework, the Agency with its facilitator role, brokering operational cooperation between Member States and the Commission and giving assistance to them, is in the best position to make a tangible contribution towards the objectives of EU fisheries control policy: establishing and developing a culture of compliance and a level-playing field.

2011 results

According to the annual work programme, the four JDPs implemented were the cod fisheries in the North Sea and Western Waters, cod fisheries in Baltic sea, regulated species in NAFO and NEAFC, bluefin tuna in the Mediterranean Sea and Eastern Atlantic Ocean and as for the 5 September 2011, a JDP for Pelagic in Western Waters through the adoption of a Specific Control and Inspection programme by the Commission. In particular, this JDP has been the first regional and multispecies JDP operating in European Union waters, and has the characteristic of being permanent, with continuous exchange of information as well as having full communication of results and intelligence in real time basis.

During the last three years, the days of activity of JDPs have been reasonably constant. In 2011, whilst the days of activity remained constant, there was a significant

increase of the total number of inspections from last year. The total number of inspections coordinated in the framework of the JDPs during 2011 is approaching 10000 in the JDPs coordinated by the EFCA.

It can be observed that the ration of infringements at sea and ashore has been decreasing in the past years. This decrease can be observed against a scenario of increased number of inspections, and the progressive introduction of a risk assessment approach with an increased infringement detection rate for target vessels. Based on this figures, it is difficult to conclude if compliance levels are increasing, as many other factors could be involved in this issue. Yet, this trend is certainly encouraging for all parties involved in fisheries control.

One of the key aspects in the promotion of a level playing field is the creation of joint teams of inspectors of different nationalities and the training of inspectors. During 2011, approximately, 1600 man/days were deployed in joint teams and a total of nearly 300 staff members from Member States received training for regional JDPs.

In the area of Capacity Building to apply the rules of the Common Fisheries Policy by Member States in a uniform way, the agency has worked in the areas of data monitoring and networks, training and pool capacities.

Seminar on the five year independent external evaluation of the EFCA

The day before the Administrative Board meeting, a seminar was organised on the five year independent external evaluation of the EFCA. It was be a forum were open discussions took place debating and analyzing the work that has been done since the setting up of the EFCA and its way forward. Representatives of the



Administrative Board as well as several stakeholders participated in the conference which conclusions and feedback would bring valuable input to the Board in the issuing of recommendations to the European Commission.

Proposed Draft Budget for 2012

The proposed draft budget for 2013 is the same as the final budget for 2012: €9,216,900.

"The EFCA will be working with the same determination and even more ambition in the difficult context of financial and staff constraints. I am confident that together, in cooperation with the European Commission and the Member States, we will be able to deliver the best results and an effective European added value," said Pascal Savouret, Executive Director.

The Council positions itself against the removal of fins of sharks on board vessels

The Council adopted a general approach whereby it supports landing of all sharks with their fins attached as proposed by the Commission (6719/2/12).

The controversial practice of "shark finning" (whereby the fins are removed from sharks, with the remainder of the shark being discarded at sea) has been forbidden on EU fishing vessels since 2003. However, a derogation still persists allowing with special fishing permits the processing on board, whereby shark fins can be removed from the carcasses (landing of fins and the remainder of the shark together or separatly). The Commission proposal aims to suppress this derogation which would mean sharks can only be landed with their fins attached.

Sharks, skates and rays are generally very vulnerable to overexploitation due to their life cycle characteristics of slow growth, late maturity and small number of young. In recent years, some shark populations have been severely targeted and put under serious threat as a result of a dramatic increase in demand for shark products, fins in particular. "Shark finning" has increased in recent years largely due to a strong demand for shark fin soup and traditional cures in Asia. While this practice is forbidden in EU waters and on EU vessels, the still possible processing on doubts board has cast about the effectiveness of controls - which relies on carcase-to-fin weight ratios - and impedes the improvement of landing statistics, the latter being necessary to allow for science-based management of shark species.
