emphasises the need for equal access to health care services and also makes suggestions concerning the required research and preventive measures.


THE SEXUALISATION OF GIRLS

Consideration of draft report

The phenomenon of sexualisation is manifested in various areas: sexualisation of products for girls such as clothes and toys, in entertainment for children and adults (movies, TV, internet, music, press) as well as in advertisements. Sexualisation



increases sexism and undermines the role of women with an impact on the image of women in the professional world. The draft report aims to sensitise public authorities on the issue and develop concrete strategies against this phenomenon.

ELIMINATING GENDER STEREOTYPES IN THE EU

In order to achieve gender equality the issue of stereotypes needs to be addressed and the committee therefore decided to draft a report on the issue. The Rapporteur looks at gender



stereotypes in media and education, on the labour market, and decision making and gives suggestions for EU actions. The long term aim is to reduce the prevalence of negative gender stereotypes which affect women and men and constrain their opportunities and choices.

Following the adoption of the negotiation mandate on 27 March on the draft report on the minimum standards on the rights, support and protection of victims of crime, negotiations have been held with Council and the Commission on this dossier. A provisional overall compromise text was agreed in the last trilogue held on 13 June, which was also endorsed by the Permanent Representatives Committee on 20 June. Members of the LIBE and FEMM committees will now have the final vote on the text as modified following the compromise reached, which will be adopted in the Plenary in September.

The Commission's proposal for the next multiannual financial period aims at simplification and



rationalisation of the existing complex structures of multiple programmes. The Rights and Citizenship Programme is proposed as the successor of three current programmes, which from the gender equality point of view, will cover the current Daphne Programme

as well as the gender equality part of the PROGRESS programme. As an associated committee, FEMM prepares its draft opinion to the LIBE committee's report in this procedure.

PROGRAMME FOR THE COMPETITIVENESS OF ENTERPRISES AND SMALL AND MEDIUM-SIZED ENTERPRISES (2014 - 2020)

Consideration of draft opinion

Within SMEs the contribution made by women has yet to reach its full potential and further work is needed to ensure that women's participation in this field improves. Increasing gender

equality in business requires a multi-faceted approach which puts forward best practice recommendations that offer choice, flexibility and opportunity for women, as it is also reflected in the draft opinion.

THE EU 2011 REPORT ON POLICY COHERENCE FOR DEVELOPMENT

FEMM committee decided to draft an opinion to the draft report of the DEVE committee, which is linked to the Commission's bi-annual monitoring report on the progress made by the EU and its Member States in making their policies more coherent with

development cooperation objectives. The draft opinion highlights the issues of maternal deaths in developing countries, the rights of the girl child and sexual violence and feminicide.

BUDGET FOR THE FINANCIAL YEAR 2013

Consideration of draft budgetary amendments

FEMM committee adopted its opinion on the Commission's draft budget for 2013 on 30 May, which was transmitted to BUDG committee and was incorporated in the EP resolution on the mandate for the trilogue on the 2013 draft budget. Now the

committee will discuss the figures and remarks to next year's budget proposed by the draftsperson. Members will then have an opportunity to table further budgetary amendments.

WOMEN'S WORKING CONDITIONS IN THE SERVICE SECTOR

Adoption of draft report

Rapporteur: Iratxe García Pérez (S&D)

The committee discussed the draft report and the 107 amendments tabled at its previous meeting. Based on that discussion, the Rapporteur proposed compromise amendments, with the aim to ensure a broad support to the report in the light of the upcoming vote.

THE ROLE OF WOMEN IN THE GREEN ECONOMY

Adoption of draft report

Rapporteur: Mikael Gustafsson (GUE/NGL)

After the discussion of the 69 amendments tabled to the original text, the Rapporteur proposed compromise amendments in order to integrate different elements and give more emphasis to the new ideas introduced by the amendments. Members will now vote on the draft report and the amendments.

ESTABLISHING A FINANCING INSTRUMENT FOR DEVELOPMENT COOPERATION

Adoption of draft opinion

Draftsperson: Rodi Kratsa-Tsagaropoulou (EPP)

The draftsperson presented the draft opinion at the previous committee meeting. Following the discussion Members tabled 64 amendments. The committee will now vote on the original text and the amendments and the final opinion will be sent to the DEVE committee.

SAKHAROV PRIZE LAUREATE LEYLA ZANA

Joint hearing DROI-FEMM



FEMM committee, jointly with the Subcommittee on Human Rights, in association with the delegation to the EU-Turkey Joint Parliamentary Committee will hold an exchange of views with Parliament's Sakharov Prize winner Leyla Zana, the first female

Kurdish MP. This discussion provides an opportunity to have a better understanding of not only Ms Zana's personal situation as human rights defender but also on the situation in her country. European Parliament awarded Leyla Zana the Sakharov Price in 1995 but she was only able to collect it nine years later, after her release from prison.
