Yalta International Economic Forum

The Yalta International Economic Forum (YIEF) is an international business event in the economic sector that is annually held in Crimea (Yalta). Along with the St. Petersburg International Economic Forum (SPIEF), the Eastern Economic Forum (EEF) and the International Investment Forum in Sochi, the YIEF is one of the top-four economic forums held in Russia. The YIEF is held under the auspices of the Presidential Executive Office of Russia. The YIEF has achieved the status of an effective international platform to discuss socioeconomic development issues, where the current agenda and challenges to the global economy can be effectively addressed.

An important YIEF focus is on searching for fundamentally new approaches and instruments to effectively address socioeconomic development issues and to discuss the best global business practices. YIEF discussions are built around the search for ways to respond to new challenges and cover a broad range of topics: the establishment of a competitive, diversified contemporary market economy that does not depend on export of natural resources, effective engagement between business and the authorities, promotion of competitive innovative manufacturing methods, mechanisms to make full use of local capacity, and support for small and medium-sized business. Emphasis is also placed on international and inter-regional cooperation.

Speakers at annual YIEF events include Russian top-ranking officials, international experts, authoritative international and Russian businessmen, economists, representatives of major business communities and other opinion leaders.

The YIEF is the main Russian platform for showcasing Crimea's investment opportunities and capacity. One of the key unique features of the region is the country's only free economic zone that encompasses the entire territory — the Crimean Federal District. The zone offers significant tax incentives, accelerated depreciation of fixed assets, and the free customs zone regime. Other advantages include the low minimum investment requirements for resident companies, a simplified procedure for acquiring the status of a resident. The YIEF traditionally features an exhibition of investment projects. Prospective investors are enabled to communicate with officials, including with Sergey Aksyonov, Head of the Republic of Crimea, who also chairs the Organizing Committee.

On the final day of the Forum, a meeting is held at Livadia Palace between the Head of the Republic of Crimea and representatives of the business community attending the Forum. The meeting is traditionally held behind closed doors, without media representatives, for any participant to share concerns, ask questions, and receive answers directly from the head of the region.

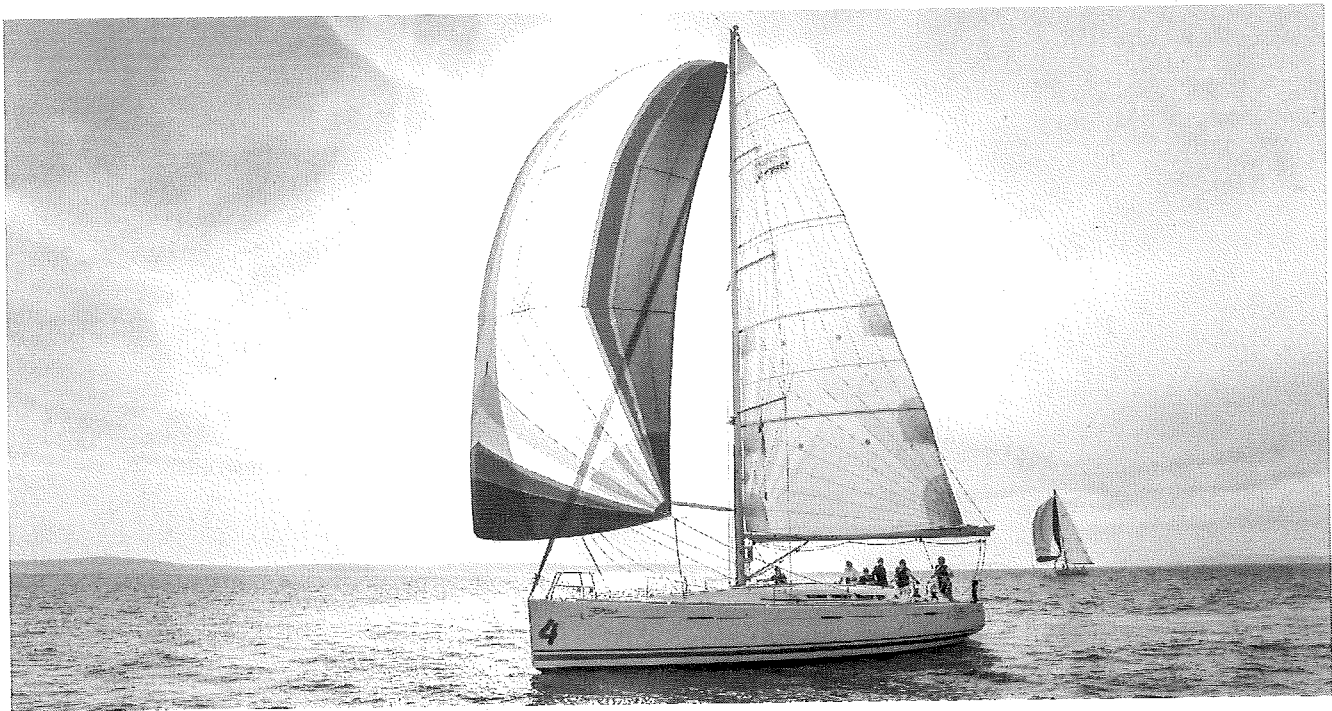

YIEF Foundation was established on August 28, 2015 by the decision of the Main Department of the Ministry of Justice of the Russian Federation in the Republic of Crimea. The decision to set up YIEF Foundation and hold the Forum on the annual basis was made taking into account successful experience of carrying-out YIEF 2015 and with an aim to turn to advantage the knowledge and experience amassed from coordinating event programming and working with participants and partners as well as maintaining high-quality organizational level.

Foundation meeting was participated by the all-Russia public organization "Delovaya Rossiya" represented by the co-chairman Andrey Nazarov, state autonomous institute "Business and Cultural Centre of the Republic of Crimea" represented by Yaroslav Ivanchenko and "Proxy Centre" company represented by Sergey Lazutkin.

Main goals of the YIEF Foundation are designing well-handled business and government interaction model, promoting integration of the Republic of Crimea into the economy of the Russian Federation in the most relevant areas, sustainable growth development and best practices and hi-tech solutions' implementation on the territory of the Crimean Republic. The Foundation is also aimed at promoting strongly support to government-aided programs' implementation of the Republic of Crimea. Consequently, fundamental mission of the Foundation is consolidation and development of the Republic's investment potential and innovative capacity.

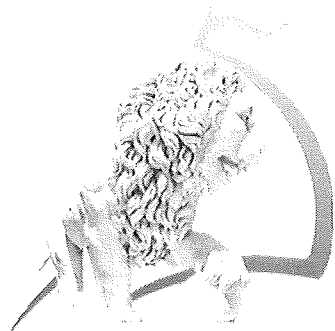

II Yalta International Economic Forum demonstrated the leap forward in its achievement. In only its second year of operation, the Forum has established itself as an effective international platform for the discussion of social and economic development issues – on both a national, and international level.

YIEF-2016 was attended by representatives of business and politics from 26 countries: Abkhazia, Armenia, Australia, Belarus, Belgium, Bulgaria, Estonia, Finland, France, Germany, China, Greece, the Czech Republic, Israel, Italy, Japan, Malaysia, Moldova, Mongolia, Nicaragua, Poland, Switzerland, Turkey, Ukraine, the United Kingdom, and the United States.

The core theme of the Forum – transforming Russia's economy in the face of challenging difficulties – underpinned all of the Forum's discussions, but was most clearly articulated in the Main Plenary Session, "Economic Growth In The Face of New Challenges". Professor Sergey Glazyev, Academician of the Russian Academy of Sciences, and Economics Advisor to the Russian President, spoke in his presentation on the need to fill the coffers of the national economy and reduce key interest rates that were brought in as emergency measures to control inflation. The Head of the Crimean Republic, Mr Sergey Aksyonov, gave a declaration in his opening address of his intention to set up an environment for business which is accessible as never before in the region.

"If there isn't enough cash in the economy, this will simply prompt inflation. When there's no money, manufacturing and investment droop. The main ways of fighting inflation should be scientific and technological progress, harnessed to manufacturing", – Economics Advisor to the Russian President, Professor Sergey Glazyev.

"We're working on the mistakes made in 2015, and we're reworking all of our administrative processes. We've set up online application and document submission on the internet for investor status. The processing times for approval in ministries and governmental departments have been cut to one working day", – The Head of the Republic of Crimea Sergey Aksyonov.

Business Programme

The programme of the second Yalta International Economic Forum comprised three days, full of business and cultural activities. First day of the forum was marked with sessions, devoted to creating and protection of favourable business environment under free trade area conditions, investments to the sea, non-commodity business strategies, development of the banking infrastructure, housing and utilities sector, HR-technologies, tourism, agriculture, wine-growing and wine-making, sports on the territory of the Crimean peninsula.

On the second day was held the Plenary session "Building a Growth Economy in the Face of New Challenges" and Grand session "Construction Industry. Modern Development Tools", where experts have discussed construction sector of the Russian Federation, state support, effective solutions and best practices in the field of construction within the Grand session. The organizers of the session became Ministry of Construction, Housing and Utilities of the Russian Federation, All-Russia Public Organization "Delovaya Rossiya".

Agreements

Over the entire period of the Forum twelve contracts were signed, for a total sum of more than 70 billion roubles. The Forum hosted the signing of a contract for the construction of a new passenger terminal at Simferopol Airport – with an investment price-tag of thirty-two billion roubles. At present, this is the

largest-scale investment project to take place in the history of the Crimean Republic. Among other biggest contracts are: an investment project for an announced investment input of 8 billion roubles – for a Meat Industry Cluster in the Chernomorsky Region; an investment project from the KCK Group Of Companies with an announced investment input of 3 billion roubles – for the construction of residential developments in Yalta and Alushte, comprising the construction and handover to Yalta City Authorities of a Children's Nursery catering for up to 50 children, as well as the building of a sports and health complex.

During the Forum proceedings, the Government of the Republic of Crimea signed a large number of interregional Memoranda of Cooperation – including with the Governments of the Orlov and Irkutsk Regions, and similarly Memoranda of Cooperation in the sphere of tourism between the Ministry of Tourism and Resorts of the Crimean Republic and the Department for National Policy, Interregional Contacts and Tourism of the City of Moscow. There was considerable interest shows in the Crimean Federal Province on the macro-economic level – memoranda on cooperation were signed between the Council of Ministers of the Crimean Republic and the Cabinet of Ministers of the Republic of Abkhazia, and the cities of Gagra and Yalta.

The Exhibition of Investment Projects of the Republic of Crimea

A new investment portal for the Republic of Crimea was unveiled at the Forum, which will enable applications for residency in the Crimean Free Economic Zone (FEZ) to be made on-line, and receive confirmation of resident status. During the portal's launch, the Head of the Crimean Republic, Mr Sergey Aksyonov gave his approval to the portal's design and set-up – and himself became the first to register as an investor.

Certificates' Award Ceremony

The high levels of demand for access to the Free Economic Zone (FEZ) created in the Crimean Republic was seen in the issue of Residency Membership Certificates for FEZ, which took place on the sidelines of the Forum.

Industry Prize Foundation

In the course of the Yalta International Economic Forum a business prize has been established. The industry prize of the Forum will be aimed at the promotion of the Free Economic Zone of the Republic of the Crimea and Sevastopol and at the encouragement of its most successful participants.

Crimean Corporate Games

Within Yalta Forum were held the first Crimean Corporate Games. General partner of the Games became KCK Group. Main events were tennis prize, football match between teams of the Government of the Republic of Crimea and participants of the Forum and Corporate Games. More than 1000 people took part in the event: head executives and authorities of the ministries, agencies and business community of the Crimean peninsula. Corporate games will be traditional event, held annually.

YIEF-2016 in Figures

Total number of YIEF-2016 participants – more than 1100 people.

YIEF brought together businessmen from 55 sectors of the economy: from IT to the aerospace industry, from tourism to oil & gas sector.

Participating in YIEF-2016 were more than 70 international delegates from 26 countries – politicians, public figures, and businessmen.

YIEF-2016 featured 30 thematic discussions breakout sessions, roundtable meetings, a plenary session, and working meetings on the YIEF sidelines. Discussions, including breakout sessions, lasted for a total of 27 hours.

More than 220 journalists representing Russian and foreign media attended YIEF-2016. More than 4500 media publications.
