### Justification

The contribution made to Rapid Border Intervention Teams should not be limited to human resources. On the contrary, they must also cover the provision of logistical resources (including surveillance systems and all kinds of aircraft, vessels and vehicles). This amendment seeks to make it clear that the technical equipment referred to in Article 7 of Regulation 2007/2004 (the Frontex Regulation) can also be used in the context of Rapid Border Intervention Teams (which was quite unclear from the original wording) and that Member States whose nationals participate in those teams will contribute the logistical resources needed for their smooth operation.
