


Amendments to a legislative text

The European Parliament,

- having regard to the Commission proposal to the Council (COM(2004)0710)¹
- having regard to Article 37(2)(3) of the EC Treaty, pursuant to which the Council consulted Parliament (C6-0000/2004),
- having regard to Rule 51 and Rule 43(1) of its Rules of Procedure,
- having regard to the report of the Committee on Agriculture (A6-0000/2004),
- 1. Approves the Commission proposal;
- 2. Calls on the Council to notify Parliament if it intends to depart from the text approved by Parliament;
- 3. Asks the Council to consult Parliament again if it intends to amend the Commission proposal substantially;
- 4. Instructs its President to forward its position to the Council and Commission.
