The meeting opened at 15.05, chaired by Raimon OBIOLS i GERMÀ.

**1. Adoption of draft agenda**

Adopted.

**2. Approval of draft minutes of meeting of 2 December 2008**

Approved.

**3. Chair's announcements**

The chair reported on his meeting the previous day, Tuesday, 27 January 2009, with a Central American ministerial delegation to examine the prospects for the sixth round of negotiations. The participants in this meeting included:

Rómulo CABALLEROS (Guatemala);

Ricardo ESMAHAN d'AUBUISSON (El Salvador);

Orlando SALVADOR SOLÓRZANO DELGADILLO (Nicaragua);

Marco VINICIO RUIZ (Costa Rica).

He also reported on the round table held that same morning with the participation of Central American parliamentarians, some of the negotiators, the Commission, and representatives of civil society.

He further announced the visit, scheduled for 11 February 2009 from 11.00, of a high-level Costa Rican delegation, consisting of the ministers for health, culture and external trade. There would be a formal meeting of the delegation for this occasion.

**4. Forthcoming visit of a delegation working group to Central America (23-27 February 2009)**

The chair set out the various options for the visit to Central America scheduled for the week of 23-27 February 2009. Following an exchange of views (speakers: MEYER, FERNÁNDEZ MARTÍN and the chair), it was agreed that the countries visited would be Costa Rica and Honduras.

**5. Exchange of views on the state of the negotiations for the EU-Central America Association Agreement**

In the context of the sixth round of negotiations for the EU-Central America Association Agreement, the chair requested an exchange of views with representatives of Central

American civil society. He stressed that Parliament's position on the negotiations with Central America is summarised in the report by Willy Meyer.

Mr FERNÁNDEZ MARTÍN expressed his appreciation of this initiative enabling a continued dialogue with representatives of civil society, and spoke on two key aspects of the negotiating process, namely problems of asymmetry and the timetable.

An exchange of views was then held with representatives of social organisations from both Central America and Europe (CIFCA, Oxfam International, Grupo Sur, APRODEV, the European Trade Union Confederation and the Central American Trade Union Platform). The speakers evoked a number of concerns and offered various suggestions regarding the negotiations for the Association Agreement. Especially stressed were: the potential impact of the agreement on development in the region; the absence of a socio-environmental impact assessment; human rights; environmental rights; and the rights of the indigenous peoples.

Winding up the debate, the chair made the following remarks:

- what is involved is more than a mere free trade agreement: importance must be laid on the political dialogue and cooperation pillars, pursuing as they do the goals of human development and sustainable development;
- continued respect for the existing asymmetries will be essential;
- it is vital to ensure respect for human rights and democracy;
- before concluding the negotiations, it will be essential to examine the issue of social and environmental impact;
- the agreement must contribute to the regional integration process.
