Finally, I headed a drive to publically promote green energy solutions and was consequently awarded the Japanese Government's "Cool Biz Award" for my efforts to promote energy savings.

Together with Afghan Minister of Education, Atmar, I spearheaded a very successful education drive in Helmand in 2007 which turned the tide against an insurgency campaign to keep schools closed and deny children access to education. Today the number of school children in Helmand has never been higher and education outreach goes even beyond government controlled areas. Negotiated in-theatre deployment of Danish troops in Helmand with the United Kingdom in Fall 2007 and Spring 2008. During the so-called second Mohammed-crisis (2008) I successfully initiated a mediation process with key Afghan religious leaders which ended the rapidly mounting violent protests against Denmark in

Afghanistan. Successfully developed and implemented a pro-active press strategy for Denmark's efforts in Afghanistan, which helped increase public support for the Government's Afghan policy and during which a majority of Danes became supportive of the Afghanistan mission in spite of continued heavy Danish losses. Finally, an external HR review concluded that I successfully created a positive and focussed working environment that helped build an extraordinary strong sense of comradeship amongst both locally employed and expat staff which made the Embassy very robust towards external pressures.
