Concerns: Overview of the legislative work of the Committee on Agriculture and Rural development and its secretariat in the period 2004 to 2009

Introduction

The purpose of this note is to provide an overview about the legislative activities of the Committee on Agriculture and Rural Development. ***Further information to the different procedures is available by clicking on the links (underlined) in the annex.***

Summary

At the moment of the EP elections in 2004, the EU had just been enlarged from 15 to 25 Member States. The CAP reform from 2003, which was designed to enhance the competitiveness of a sustainable and more market-oriented agriculture in the enlarged EU, just entered into force.

The legislative period 2004- 2009 thus started with an intensive discussion about the Multiannual Financial Framework 2007-2013, to which the Committee on Agriculture and rural development actively contributed.

As a consequence of the 2003 CAP reform, several major market reforms were adopted, introducing the Single Common Market Organisation in 2006 and reforming the market organisations for sugar (2005), fruit and vegetables (2007) and wine (2007). In addition, the Community rules for the milk sector were revised in 2007.

The "second pillar" of the CAP, the rural development policy, was subject to a thorough reform in 2005/2006. In parallel, the main Community legislation regarding the promotion of food quality (e.g. geographical indications or organic farming) was renewed in 2005. The Committee also contributed to key legislation regarding animal health and food safety issues (e.g. on avian influenza, TSE and animal feed).

The second half of the legislative term was dominated by the Health-Check of the CAP, which was adopted in November 2008 (for more detailed information, see Activity report 2008).

The discussions about the Health Check were held in a context of growing concern about climate change, the use of agricultural products as renewable energy sources and the global food crisis in 2008. The Committee adopted several legislative and non-legislative reports regarding these new challenges.

The Committee also drafted several legislative and non-legislative reports with regard to the protection of animal welfare, e.g. the Action plan on animal welfare 2006-2010 and legislation on animal testing and protection of animals at the time of killing (2008).
