

SHORT JUSTIFICATION

Commission's Proposal

The Commission has proposed a Regulation for the establishment of the European Statistical Programme, which will provide the framework for the development, production and dissemination of European statistics over the period from 2013 to 2017.

The total amount to be borne by the budget of the EU is 299.4 million EUR (current prices) for the duration of the programme.

General Context


In accordance with Regulation (EC) No 223/2009 of the European Parliament and of the Council on European Statistics, a multiannual European statistical programme should be established, providing a framework for EU actions. The current Community Statistical Programme (CSP), covering the period from 2008 to 2012, is the seventh of its kind.

The European Statistical Programme will provide the framework for the development, production and dissemination of European statistics over the period from 2013 to 2017. It is to lay down priorities concerning the needs for information for the purpose of carrying out the activities of the European Union. Those needs should be weighed against the resources needed at Union and National level to provide the required statistics, and also against the response burden and the respondents' associated costs.

The ESP will be the subject on an interim progress report and a final evaluation report after the expiry of the programme period.

The European Statistical System (ESS) is the partnership between the Community statistical authority, which is the Commission (Eurostat), and the National statistical institutes (NSIs) and other national authorities responsible in each Member State for the development, production and dissemination of European statistics. In recent years the ESS has been faced with a number of challenges:

- Firstly, the need for European statistics has been constantly increasing, and this trend is unlikely to change in the future.
- Secondly, the nature of statistics has changed evidence-based decision making requires statistics that meet quality criteria linked to the specific purposes they are serving, and there is a growing need for complex multidimensional statistics supporting composite policy areas.
- Thirdly, due to the appearance of new actors on the information market, including those providing information in nearly real time, the priority for the ESS in the future is quality and, in the case of short-term statistics, timeliness in particular.
- Fourthly, budget constraints at both National and European level, as well as the need to further reduce the burden on enterprises and citizens, make the situation even more challenging.



Priorities & Objectives

The main purpose of European statistics is to underpin the development, monitoring and evaluation of European policies with reliable, objective, comparable and coherent factual information.

The general objective of the ESP is for the European Statistical System to be the leading provider of high-quality statistics on Europe.

The following overriding objectives shall be pursued in all statistical actions undertaken for the implementation of this programme:

- Objective 1: provide quality statistical information to support the development, monitoring and evaluation of the policies of the EU properly reflecting priorities;
- Objective 2: implement new methods of production of European statistics aiming at efficiency gains and quality improvements;
- Objective 3: strengthen the partnership within the European Statistical System and beyond in order to further enhance its productivity and its leading role in official statistics worldwide.

Furthermore, in order to implement the ESP, the Commission shall adopt annual work programmes which will set out the objectives pursued and the expected results.


Financing

The financial envelope for the implementation of this programme is set at 299.4 million Euros, including 57.3 million Euros covered by the programming period 2007 to 2013, and 242.1 million Euros covered by the programming period 2014 to 2017.

Amendments

In light of the financial crisis, and particularly the fact that the crisis was aggravated by the lack of timely, accurate, and high-quality national statistics, your Rapporteur would suggest the following:

- High-quality national statistics are absolutely essential for the purpose of policymaking at both national and EU level, and in the context of the Eurozone's supervisory mechanisms.
- Actions taken under the ESP must be closely and regularly monitored to ensure accuracy and efficiency, and prevent irregularities; inspections and spot-checks must be routinely carried out as a rule rather than at the discretion of the Commission (Eurostat) or the European Anti-Fraud Office (OLAF).
- The independence and integrity of national statistical authorities must be strongly guarded, with transgressions deterred through effective penalties. In the interests of transparency, Eurostat will publicise information on the quality of national statistics, with particular attention to those national statistical authorities that underperform on a routine basis.

its statistical authority. Interference by governments with the independence of national statistical authorities shall be effectively deterred through appropriate measures.

In the interests of transparency, Eurostat shall disclose publicly its opinion on the quality level of national statistics. Any recurrent underperformance of national statistical offices shall be highlighted and made public in as timely a manner as possible. To this effect, Eurostat's periodic updates shall provide specific information on each Member State.
