The Commission considers that fraud and related illegal activities affecting the Union's financial interests are a serious problem to the Union's budget and thereby the tax payers. For that reason, making use of the possibilities offered by the Treaty on the European Union, the Commission launched a proposal for a Directive on the fight against fraud to the Union's financial interests by means of criminal law. The Rapporteurs share the Commission's views on the problem and welcome the proposal. The *acquis communautaire* in the field of the fight against fraud, even though well-structured, is very

fragmented creating incentives for potential perpetrators to move across European territory to the most favourable judicial system.

The Rapporteurs tried to further improve the proposal by putting 23 amendments to the draft report.

Amendments proposed to make more precise the definition on the Union's financial interest and specify irregular activities in public tenders. It is also proposed to abolish the categorisation of offences as 'minor' and/or 'serious' and decrease the offences' threshold.

The Rapporteurs believe that it is appropriate to establish a minimum level of criminal sanctions to ensure a degree of consistency across the EU on sanctions imposed on those who defraud the EU's financial interests and that the minimum sanctions proposed to fraud, on the one side, and corruption and money-laundering, on the other, should reflect the differences between those offences. Lastly, the Rapporteurs want to ensure close cooperation between the Members States and the relevant Union institutions and agencies on investigating and prosecuting fraud.

The legal affairs committee is associated under Rule 50 of the Rules of Procedure and has already adopted the opinion of the Rapporteur Tadeusz Zwiefka in November. The opinion will be integrated into the report without voting since it concerns matters which fall within its exclusive competence.
