Exchange of views following Parliament's first reading

Mrs. Paliadeli explained the next steps in the European Heritage Label dossier (COD 2010/0044). The EP held its first reading in the course of the December 2010 part-session: it adopted 62 amendments to the Commission proposal. The Hungarian presidency of the Council is keen to conclude the dossier with an early second-reading agreement ahead of the May Culture council: to this end, and once the presidency has a negotiating mandate from Coreper, trilogues might be held. The Committee took a decision by vote to enter into negotiations on the basis of the EP first reading position; that the EP negotiating team should consist of the Chair and rapporteur; and that these would report back to closed meetings of the shadows after each trialogue.
