a) One of the coordinators expressed concerns about the quality of the translations of Mrs. Sanchez-Schmid's draft report on the cultural and creative industries. After a discussion, it was agreed that Members should draw any such concerns to the attention of the secretariat, which will ask the translation services to check the texts concerned.

b) Following a discussion, the coordinators decided that, from now onwards, the final deadline for groups to request changes to draft voting lists will be 14h00 on the day before the relevant vote.

c) Two coordinators asked whether the secretariat could show some flexibility in the case of late submission of amendments. The secretariat took the floor at the request of the Chair and said that this was not possible because the deadline for amendments agreed by the Committee is entered in the computerised system for tabling also because amendments and the system will not accept amendments tabled after this deadline; and the secretariat has no margin of discretion in this matter, since deadlines are fixed by the Committee itself and are binding on the secretariat.
