

*Delegation for relations with Afghanistan***D-AF_PV(2011)1004-01****MINUTES**
of the meeting of 4 October 2011, from 17.30 to 18.30
Brussels

The meeting opened at 17.41 on Tuesday, 4 October 2011, with Thijs Berman (Chair) in the chair.

1. Adoption of agenda

The Chair announced that active and passive interpretation would be available in the following languages: FR, DE, EN, IT, ES.

The Chair added that no provision had been made for Occitan.

The agenda was adopted.

2. Approval of minutes of meeting of 21 June 2011

The draft minutes were adopted unchanged.

3. Chair's announcements

The Chair announced that the second Bonn Conference on Afghanistan would finally take place on 5 December 2011, 10 years after the conference that had produced the 2001 Bonn Agreement following the fall of the Taliban.

Three topics would be explored: (i) the civil aspects of the transition until 2014, (ii) the international community's long-term commitment in Afghanistan and in the region after 2014, and (iii) support for the ongoing political process.

As regards the organisational aspects, Mr Berman announced that as things stood Germany's Ministry of Foreign Affairs did not intend that Parliament should be formally represented.

Mr Berman expressed regret at this decision, particularly as it would be Parliament that would subsequently be called on to approve the use of Community funds in Afghanistan.

Furthermore, the topic would soon be on the plenary agenda, given that the Committee on Budgetary Control was already looking into it. However, it might be possible for Parliament to be represented on the EU delegation, in particular under the terms of the Interinstitutional Agreement between Parliament and the Commission, which dealt with just such cases as this.

4. Exchange of views on the situation in Afghanistan

Mr Berman outlined the chronology of certain recent events:

In late September 2011, Admiral Mike Mullen, Chairman of the US Joint Chiefs of Staff, had declared that the Pakistan Intelligence Service was using the Haqqani network as a weapon and had, in particular, helped it prepare its attack on the US Embassy in Kabul at the beginning of that month.

These claims had of course been denied by the Pakistan Government.

On 20 September 2011, Kabul had been hit by a new attack, a week after that on the US Embassy. Former Afghan President Burhanuddin Rabbani, who was leading the peace negotiations with the insurgents, had been killed in his own home in a suicide bombing; the assassination of the former President sent a clear political message, since he had headed the High Council for Peace, created in the previous year to negotiate with the insurgents.

The Afghan committee of inquiry set up to investigate this assassination and headed by the Minister of Defence had concluded that the suicide bomber was a Pakistani national and that the attack had been prepared in Quetta, Pakistan.

In a major development, it seemed that President Karzai was on the point of altering his strategy in his attempts to negotiate with the Taliban: he had been quoted as saying that 'the only solution is to hold talks with Pakistan because all the Taliban's safe havens are in that country'.

Mr Cozzolino, Mr Fidanza, Mr Berman and Mr Arlacchi wondered what the future held for Afghanistan.

Ambassador Tandar answered. He explained that his government had for many years dedicated all its energy to revitalising the peace process by taking decisive action - such as the creation of the High Council for Peace. As things stood, though, 'we are alas forced to admit that no tangible result has been obtained'. The only response to the Afghan Government's call for peace had been blood, executions and violence. Senior government officials responsible for negotiating peace were now priority targets. History would judge, but 'we have done everything we could, and even accepted certain demands regarding the composition of the government'. Pakistan continued to harbour members of the Taliban: 'we have proof of the Pakistani secret service's involvement and of their support for the Taliban - with whom direct talks are now pointless'.

Mr Tandar announced, however, that the option of a political settlement had not been abandoned: 'it is only the choice of negotiating partners that is different'; he hoped that Pakistan would hold talks with Afghanistan, which was after all a sovereign power. By the same token, President Karzai certainly intended to make his planned official visit to New Delhi. Would this visit stir up regional tensions? 'We are not psychiatrists. If we are surrounded by sick people, let them seek treatment'.

That being said, Afghanistan would never be a threat to its neighbours, 'and we are ready to make any binding commitment to that effect'. The Ambassador explained that his country was reaching out to Pakistan's civil society, its Parliament and its Government - even though in fact the Pakistan army was really in control.

Mr Arlacchi, vice-chair, spoke. He fully endorsed Ambassador Tandar's analysis, highlighting the need for realism. This was also the view of the US, which had changed its strategy in the previous few months. Addressing the representative of the European External Action Service (EEAS), he wondered if it might also review its approach, taking greater account, for example, of Parliament's point of view. He emphasised that since the adoption in plenary of the report on a new strategy for Afghanistan, 'not one single element has been taken into account'.

Ms Muscheidt (EEAS) rejected this suggestion, at the same time calling for a broader discussion. She mentioned that issues such as international aid effectiveness had also been looked into in other forums (the Paris Declaration Evaluation, for example). She also emphasised that, irrespective of internal European Parliament debates, an Afghan national development strategy had already been drawn up, and that, for the EEAS, this overrode all other considerations. Ms Muscheidt particularly stressed the importance of the Afghanistan Reconstruction Trust Fund (ARTF), to which the EU was a contributor. Parliament was kept informed, in detail, about the use of these funds on a six-monthly basis, and she deplored the fact that the information was not being passed on to all the relevant individuals and bodies in Parliament.

The next meeting of the delegation would be held on Tuesday, 22 November 2011 at 9.00. The Chair stated that it would involve an exchange of views, by video-conference between Brussels and Kabul, with NGOs active in Afghanistan; since video-conference interpreting was possible only in exceptional cases, the meeting would therefore in all likelihood be held in English.

The meeting closed at 18.28.
