EU-Australia/New Zealand relations

The current basis for the EU-Australia relationship is the EU-Australia Partnership Framework that was adopted in October 2008 in Paris. This deepens the overall framework of the partnership by strengthening multilateral and bilateral dialogue.

The framework for the EU-New Zealand relationship is the EU-New Zealand Joint Declaration on Relations and Cooperation which was adopted in September 2007 in Lisbon. There is currently discussion about how this might be further upgraded through a comprehensive international EU-New Zealand Agreement covering political and security areas as well as economic areas.

Relations between the EU and the two countries are underpinned by trade but there has been an expansion in recent years of political and economic links. The partners cooperate closely on challenges such as security and counter terrorism, development aid, stability in the Asia-Pacific region, energy, the environment and climate change. There are annual consultations between the Foreign Ministers and Senior Officials and a range of sectoral dialogues covering areas such as trade, agriculture and the environment.

Activities of the European Parliament delegation

Every year, if possible, the delegation visits one of the partner countries and hosts a visit from the other counterpart; e.g. in 2008 the Australian delegation came to Brussels and the European Parliament delegation visited New Zealand.

The delegation has 23 members, of whom 20 members plus the Chair are entitled to travel in every two year period.

The visits of the Australian and New Zealand counterparts to Europe are centred on a formal interparliamentary meeting with an agreed agenda. The subjects on the agenda include the EU-Australia/New Zealand relationship; agriculture; environment and climate change; energy issues; education; developments in the EU and Australia/New Zealand; immigration and global politics. The meetings of the visiting members with the European Parliament are one element in a broader programme of meetings in Europe.


Visits to Australia and New Zealand of the European Parliament delegation focus on a specific theme; e.g. the visit to Australia in February 2009 concentrated on climate change and the financial and economic crisis. The central part of the visit to the two countries is the time spent meeting with parliamentary counterparts in Canberra and Wellington. A further standard feature of the delegation visits is meeting with university staff and students in which the MEPs give an overview of developments in the EU.

In addition to the meetings with the Australian and New Zealand parliamentarians there are also ongoing contacts with the Missions to the EU of the two countries and other individuals and bodies involved in the relationship.

Future activities

A visit to Brussels by a delegation from the New Zealand Parliament is anticipated on 14 and 15 October 2009. If the current rhythm of meetings is maintained in 2010 there will be a visit to New Zealand at some point in the year and an incoming delegation from Australia around April.
