Meeting of 21 July 2009, from 10.30 to 12.30
BRUSSELS

The meeting opened at 10.40 on Tuesday 21 July 2009, with Eva Joly (Chair) in the chair.

1. Adoption of agenda

DEVE_OJ PE427.130v01-00

The agenda was adopted as reflected in these minutes.

2. Chair's announcements

The Chair drew attention to the forthcoming Presidential and Provincial Council elections in Afghanistan scheduled to take place on 20 August 2009, to which the European Commission is deploying an EU Election Observation Mission (EOM), funded from the Development Cooperation Instrument (DCI). She also mentioned the recent presidential elections in Mauritania.

3. Announcements by the European Commission

Mr Manservisi, the Commission's Director General for Development, presented the main policy areas and priorities of the European Commission in the field of development to the new members of DEVE Committee.

4. Chair's announcements concerning coordinators' recommendations

The committee will request authorisation to draft own-initiative reports on:

- "The effects of the global financial and economic crisis on developing countries and on development cooperation"
- "The mid-term review of the geographic and thematic strategy papers under the DCI"

The committee will draft opinions on:

- COM (2009)0197: Proposal for a Council Regulation amending Regulation (EC) No 1934/2006 establishing a financing instrument for cooperation with industrialised and other high-income countries and territories.
- COM (2009)0195 - 2009/0058 (COD): Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EC) No 1717/2006 establishing an Instrument for Stability.
- COM (2009)0120 - 2009/0038 (CNS) - C7-0003/2009: Proposal for a Council Regulation on the conclusion of the Fisheries Partnership Agreement between the European Community and the Republic of Guinea (and close the procedure started during the previous parliamentary term).

The committee will organise a hearing on the conclusions and recommendation of the European Court of Auditors' special report No. 4/2009: The Commission's management of non-state actors' involvement in EC development cooperation:

The committee decided to establish 5 permanent working groups for the democratic scrutiny of the legal instruments for development cooperation and humanitarian aid:

- WG A: Central, East & South-East Asia, "Investing in People"
- WG B: South & West Asia, Environment
- WG C: Latin America: North & Central, Migration and asylum
- WG D: Latin America: South, South Africa, Non-state actors in development
- WG E: Food Security, Food Facility Regulation, Humanitarian Aid Regulation, ACP Sugar Protocol Countries

Also the budget working group will continue.

The committee will request authorisation for a question for oral answer with debate and a winding-up resolution (Rules of Procedure, Rule 115) on:

- climate change and developing countries;
- the effects of the global financial and economic crisis on developing countries and on development cooperation

The existing calendar for DEVE meetings in 2009 was reconfirmed.

The arrangements agreed by the previous DEVE committee for the right of scrutiny procedure under comitology during the summer recess were reconfirmed.
