MINUTES

of the meeting of 5 October 2010, from 17.30 to 18.30
Brussels

The meeting opened at 17.35 on Tuesday, 5 October 2010, with Christian Ehler (Chair) in the chair.

1. Adoption of draft agenda (PE 446.320)

The draft agenda was adopted without modification.

2. Adoption of draft minutes of 2 June 2010 (PE 446.322)

The draft minutes were adopted without modification.

3. Chairman's announcements

The Chairman informs Members that the bilateral EU-Korea summit will take place on 6 October 2010, in the margins of the ASEM (Asia-Europe) summit, which brings together 48 Member States in Europe and Asia, representing 60% of world population and global trade. The Republic of Korea will be represented by President LEE Myung-bak and it is intended to sign the EU-Korea FTA at the bilateral summit.

The chairman also draws the attention of Members to his draft report on the mission that took place on 7 -11 June 2010 to South Korea. At that time, following the publication of the report on the sinking of the "Cheonan" vessel, the delegation decided that it was appropriate to postpone the visit to North Korea, but to go ahead with the mission to South Korea. Members were invited to send their observations to the secretariat.

4. State of affairs concerning the EU-Republic of Korea Free Trade Agreement

The Chairman invites Mr Pablo Zalba, rapporteur in the International Trade Committee on the EU-Republic of Korea safeguard clause, to brief Members on the latest state of affairs concerning his report. Mr Zalba draws the attention of Members to the expected timetable for the adoption of his report in plenary, and to the pending issues of negotiation with Council, including the question of duty drawback, the possibility for the European Parliament to request an investigation, and commitology issues. It is expected that the Free Trade Agreement, to be signed at the bilateral EU-Republic of Korea summit on 6 October 2010, will enter into force provisionally by 1 July 2011, provided that the safeguard clause has been adopted and that the European Parliament has given its consent to the Free Trade Agreement. If agreement is reached on the pending issues, the rapporteur notes that his report can be voted in plenary at the 18-21 October 2010 sitting.

The Chairman also invites Mr Berz, representative of the European Commission (DG TRADE), to intervene. Mr Berz also refers to the pending issues of negotiation and the expected timing.

5. Working programme 2011

The Chairman draws the attention of Members to the proposals concerning the working programme for 2011, which have submitted to the Conference of Presidents for authorisation. These include an inter-parliamentary meeting with the National Assembly of South Korea in Brussels (January or February 2011), and inter-parliamentary meetings with both the Democratic People's Republic of Korea and the Republic of Korea in May 2011. These activities are still subject to confirmation.

The proposed programme is endorsed by Members.

6. Any other business

7. Date and place of next meeting

The next meeting is scheduled to take place on 30 November 2010 at 15 hrs in Brussels.
