



# Delegation to the Euro-Latin American Parliamentary Assembly

DLAT PV(2011)0511

#### **MINUTES**

of the meeting of 11 May 2011, from 17.30 to 19.00 Strasbourg

The meeting opened at 17.40 on Wednesday, 11 May 2011, with José Ignacio Salafranca Sánchez-Neyra in the chair.

# 1. Adoption of draft agenda

The agenda was adopted as shown in these minutes.

# 2. Approval of minutes of meeting of 6 April 2011

The minutes were approved.

#### 3. Chair's announcements

The Chair informed the meeting that a parliamentary network for cooperation with the Latin American and Caribbean Parliaments had been created on 15 April 2011 in Panama. It would be an administrative network like those which already existed in relation to parliaments in Europe (European Centre for Parliamentary Documentation and Research) and Africa (Africa Parliamentary Knowledge Network, set up in 2008). The new network basically aimed to offer physical infrastructure and electronic platforms through which the different parliaments could exchange their best practices and have access to technical assistance and experts on interparliamentary cooperation.

# 4. Outcome of the meetings of the Executive Bureau and the working group on migration in Cartagena de Indias (28 and 29 April 2011)

The Chair outlined the main results of the above meetings. On the one hand, the PV\867287EN.doc PE446.770v01-00

working group on migration had held a lively exchange of views with various representatives of the International Committee of the Red Cross, the Colombian Government and Chamber of Representatives, and the EU Ambassador, representing the High Representative, Baroness Ashton. The Latin American side reported that a specific proposal on the creation of EU-LAC migration observatories would be presented at the group's next meeting in Montevideo. Attention was also drawn to the need to update the recommendation drafted by the working group at its previous meeting in Seville, in May 2010, in order to reflect the changes in EU migration policy since then, as well as migration issues arising within and amongst the Latin American countries themselves. During the meeting, the European Co-President, Agustín Díaz de Mera, said that he would be unable to attend the group's next meeting in Montevideo owing to the Spanish electoral timetable, and he asked co-rapporteur María Muñiz de Urquiza to stand in as the European Co-President at the group's Montevideo meeting, to which she agreed. On the other hand, the meeting of the Assembly's Executive Bureau had drawn up the draft agenda for the Plenary Session, approved the various reports and topics for discussion by the three standing committees and decided to draft separate declarations (Article 18 of the Rules of Procedure) on the current situation in the Southern Mediterranean and in the Persian Gulf, and on climate change in preparation for the UN conference due to be held in Durban in December 2011. The members of the Bureau were also told of the Latin American component's decision to increase the number of Parlasur representatives in the Assembly from 13 to 15 (reducing the number of Parlatino representatives from 31 to 29) and to rotate the Co-Presidency of the Assembly every two years, with the next turn being Parlacen's, starting immediately after the plenary session in Montevideo. Concerning the starting-up of the EU-LAC Foundation, a meeting of the Group of High-Level EU-LAC Officials (future executive board of the association) had been held in Santiago de Chile to discuss the question of the Foundation's legal statute and the appointment of its authorities, namely the chair (former Commissioner Benita Ferrero-Waldner) and executive director (the Peruvian Ambassador in Brussels, Jorge Valdés), given that both appointments needed to be made by consensus under a regional rotation system. Both appointees would shortly be invited to a meeting of the Delegation. Mention was also made of the Foundation's budget for 2012. With regard to the EuroLat Assembly's participation in the Foundation's Executive Board, as provided for in the Terms of Reference presented at the Madrid Summit, it was felt that the matter should be raised directly with the Foundation by the Co-Presidents of the Assembly, or by some other particularly qualified representative of its Executive Board.

The Chair also emphasised that the Cartagena meeting had been a resounding success in political terms, since it had been supported throughout by the Colombian Government, as demonstrated by the participation of and lengthy exchange of views with the Colombian vice-President, Angelino Garzón, who had already confirmed his presence at the Montevideo meeting at the invitation of the two Co-Presidents. The Colombian vice-minister for External Affairs, Mónica L. Mutis, also took part in the Cartagena meeting.

- 5. Preparations for the fifth ordinary plenary sitting of the Assembly and the meetings of the standing committees, the Executive Bureau and the working group on migration, in Montevideo (17 to 19 May 2011)
  - Consideration of the draft agenda for the plenary session

The Chair said that around 38 Members had already confirmed their attendance. While recognising the difficulties involved (a long and tiring journey and, in particular, the forthcoming elections in Spain and Portugal), he appealed to the political groups to increase PE446.770v01-00

the European Parliament's participation in the Montevideo meeting. He went on to say that the joint programme included meetings of the working group on migration, the Executive Bureau of the Assembly (ordinary), the three standing committees and the celebration of the Fifth Ordinary Plenary Session. The agenda would include for the first time a presentation to the plenary of the EU-LAC working group on migration's activities and the results of the EuroLat - civil society meeting, as decided by the Executive Bureau at Cartagena. Responding to the request put forward by the coordinator of the Socialist Group, Luis Yáñez, the programme would, as usual, include meetings of the various political families wishing to do so, on Tuesday 17 from 14.00 to 15.30, as well as meetings of the various EP permanent delegations and their Latin American counterparts on Wednesday 18 from 11.30 onwards. The plenary session would take place in the Legislative Palace in Montevideo, which was a National Historic Monument, and would form part of the national programme of celebrations of the bicentenary of the independence of Uruguay. He drew members' attention to the joint formal opening ceremony, which would be attended by the President of the Republic of Uruguay, José Mujica. Others who had confirmed their presence at the ordinary plenary session included Angelino Garzón, Vice-President of Colombia, Alicia Bárcena, executive secretary of the Economic Committee for Latin America and the Caribbean (CEPAL), and Dante Caputo (OAS) and Álvaro Pinto (UNDP), who would be presenting and discussing the UNDP report on democracy 'Our Democracy'.

# • Debate on the standing committees' documents and activities

The Chair said that the following had also confirmed their participation: Eduardo Bonomi, Uruguayan Minister of the Interior, for the Committee on Political Affairs and Security; Enrique Pintado, Uruguayan Minister of Transport and Public Works, for the Committee on Economic, Financial and Commercial Affairs; and Eduardo Brenta, Uruguayan Minister of Labour and Social Security, for the Committee on Social Affairs, Human Exchanges, Environment, Education and Culture. He added that the amendments and voting lists for the three joint motions for resolution had recently been distributed, as had documents concerning the topics for debate. Finally, he thanked the rapporteurs and shadow rapporteurs from the various political groups for their work on the documents in question.

# • Progress of work undertaken in the working group on migration

The Chair said it was expected that a specific proposal for the creation of the EU-LAC Migration Observatory would be presented in Montevideo. A decision would also have to be taken on updating the recommendation drafted by the Working Group before the Madrid Summit, to include changes in EU migration policy since then as well as migration issues arising within and amongst the Latin American countries themselves.


