MINUTES

of the meeting of 28 February 2013, from 9.00 to 11.00 Brussels

The meeting opened at 9.10 on Thursday, 28 February 2013, with José Ignacio Salafranca Sánchez-Neyra (Chair) in the chair.

1. Adoption of draft agenda

3. Chair's announcements

The Chair said that he would be writing to Parliament's President, Mr Martin Schulz, to request permission from the Conference of Presidents to increase the number of the delegation's permanent substitute members. He announced his intention of inviting Mr Schulz to attend a forthcoming meeting of the delegation so that he might report to members on his recent successful trip to Mexico, Costa Rica and Colombia. Lastly the Chair announced his intention of holding a joint meeting with the D-MX and DMER delegations to obtain an overview of the implications the future Transatlantic Trade and Investment Partnership Agreement between the European Union and the United States would have for EU-LAC relations. A joint meeting with the D-MX, DAND and D-CL delegations would also be arranged to discuss the implications for EU-LAC relations of the Pacific Alliance launched in June 2012.

4. Revised Programme of Activities for the Delegation to the Euro-Latin American

Parliamentary Assembly in 2013

The Chair pointed out that the Conference of Presidents had approved the Eurolat Assembly's 2013 Programme of Activities, which had scheduled the Ordinary Plenary Session for 23 to 25 January 2013 in Santiago, Chile, in its decision of 31 January 2013. The Ordinary Plenary Session had now taken place and would in fact be the only ordinary plenary session held in 2012 and 2013, which would certainly constitute in itself a significant saving in budgetary terms. The approved programme also listed an Executive Bureau meeting on 29 and 30 April 2013 in Santo Domingo (Dominican Republic), as well as meetings of the standing committees, the Executive Bureau and the Migration Working Group and interparliamentary meetings of the DAND, DMER and D-CAM delegations on 9 to 11 July (in Brussels) or 15 to 17 July (in Prague) at the invitation of the President of the Czech Republic's Senate (in the event no such invitation had not been received). The Chair went on to say that meanwhile he had received a copy of the letter the President of the Seimas (the Lithuanian Parliament) had sent to Mr Schulz, in which the Eurolat Assembly had been invited to hold its next meeting of standing committees at the Lithuanian Parliament's seat in Vilnius, on 16 to 18 July 2013, on the occasion of Lithuania's holding the Presidency of the Council of the European Union for the first time. He proposed that this invitation should be accepted and submitted to the Conference of Presidents for authorisation, together with the corresponding financial statement in order to verify that the cost would not greatly exceed, or could even be lower than, the cost of holding the meeting in Brussels, in line with current budgetary restrictions.

The Chair also asked delegation members to consider whether the date of the Executive Bureau meeting originally scheduled for 29 and 30 April 2013 in Santo Domingo should be changed to 19 and 20 September 2013, and the meeting enlarged to include the Coordinators of the Assembly's political groups. Firstly, changing the date would mean the activities of the Assembly's bodies could be more evenly distributed throughout the year. Secondly, and most importantly, it would stop an excessive number of activities being concentrated in Week 18 (29 April to 3 May) when another three visits by EP delegations to Latin America were scheduled (DAND to Peru, DMER to Argentina and Uruguay, and D-MX to Mexico). The Chair proposed two options for this meeting's location: i) Santo Domingo, as originally planned, or ii) Havana, as Cuba was holding the CELAC Presidency during 2013.

The Chair reminded members that all the dates proposed for external meetings of the group of Assembly bodies in 2013 would follow current European Parliament regulations, which required these to be organised in principle during the 'turquoise' weeks reserved for external parliamentary activities.

<u>Decision:</u> The revised draft programme of activities for 2013 was approved, both in regard to the Eurolat committees meeting in Vilnius (in light of its cost in comparison with Brussels, in line with current EP budgetary guidelines) and in regard to the Executive Bureau meeting being enlarged to include the Political Groups' Coordinators, who together with the delegation members were in favour of this being held in Havana, provided the Cuban authorities

sent the corresponding invitation and the Latin American component agreed. The revised programme would be submitted for approval now to the Assembly's Executive Bureau and the relevant bodies in the European Parliament.

5. Evaluation of the Sixth Ordinary Plenary Session of the Assembly, the meetings of the standing committees, the Executive Bureau and the Working Group on Migration in Santiago de Chile (23-25 January 2013)

The Chair began by thanking the Chilean organisers for their outstanding support and asked that his congratulations to the EP Secretariat for the excellent way they organised the Assembly's meetings in Santiago be recorded in the minutes. Above all, he wished to highlight and thank the Members of the Assembly for their impressive attendance and participation in Santiago. There were 62 Members of the EP and 64 Members of the Latin American component (126 Members of the Assembly in total) present at the Assembly's meetings, to which had to be added another dozen Members of national European and Latin American parliaments and of the Chilean Senate. The Chair then presented the Executive Bureau's discussions and decisions, and in particular: i) final approval of the joint programme for the Sixth Ordinary Plenary Session and related meetings; ii) rejection of a proposal that a new Working Group on 'Prevention of natural disasters in Europe and Latin America' be created; iii) the Committee on Political Affairs, Security and Human Rights charged with re-examining the Islas Malvinas/Falklands issue (both terms to be used in documents in Spanish); iv) presentation of and discussions on a draft Message to the CELAC-EU Summit, with the Secretary and Advisers of the political groups responsible for its definitive conclusion and negotiation under the supervision and ultimate authority of both Co-Presidents; v) discussion of the initiative to commemorate the 40th anniversary of the death of former President Salvador Allende and the Bureau's subsequent decision to inform all Members of the Assembly of this so that those who so desired would be able to take part voluntarily in the commemorative ceremony.

The Chair reported next on the meetings held in Santiago and the specific results thereof, including: i) the working dinner held by the two Co-Chairs of the Migration Working Group with the President and Executive Director of the EU-LAC Foundation, the EEAS and the Chilean Co-Presidency of the CELAC-EU Summit on prospects for establishing the European EU-LAC Migration Observatory; ii) the inaugural session which had included speeches by Mr Sebastián Piñera Echerique, President of the Republic of Chile, Mr Nicolás Monckeberg, President of the Chamber of Deputies of Chile; Mr Camilo Escalona, President of the Senate of the Republic of Chile; Mr Pío García Escudero, President of the Spanish Senate; Baroness Ashton, High Representative of the Union for Foreign Affairs and Security Policy/Vice-President of the European Commission; Ms Alicia Bárcena, Executive Secretary of ECLAC, and the Assembly's two Co-Presidents; iii) the plenary session where, in addition to discussing and approving the three reports prepared by the standing committees, Chile's Foreign Affairs Minister Mr Alfredo Moreno had made a speech; Mr Jean-Pierre Audy had been appointed as the EP Co-Vice-President of the Assembly in place of Ms Amalia Sartori and a majority of the members of the Executive Bureau had been elected from said component, including the new Co-Chair Mr Leonel Búcaro, President of the Central American Parliament, whose term-inoffice would begin in the middle of May 2013; iv) speakers in the closing session had been Mr Gianni Pitella, Vice-President of the European Parliament representing the EP's President Mr Martin Schulz; Mr Enrique V. Iglesias, Secretary General of the Ibero-American General Secretariat, and the Assembly's two Co-Presidents; v) work done by the Assembly's three standing committees had been excellent, with discussions on their respective draft joint resolutions and working documents. The Chair then congratulated Co-Vice-President Perelló Rodríguez on the successful organisation of the meeting with civil society, and on the high turnout at the Euro-Latin American Women's Forum. He also thanked members of the Assembly's various political families (namely the PPE, S&D, GUE/NGL, ALDE and ECR groups) for the part they had played in the various Group meetings held with their Latin American counterparts at the start of the Assembly's work.

Looking overall at the meetings in Santiago, the Chair highlighted: i) the excellent turnout of Members at the plenary session as mentioned previously; ii) the extraordinary welcome and hospitality and the enormous political, logistical and media backing given by the Government, the Congress, the Senate and the media in Chile, which the presence of the President of the Republic Mr Sebastián Piñera Echenique had clearly demonstrated, and stressing the support and personal commitment of the Co-Vice-President responsible for organisation, Mr Jorge Pizarro Soto; iii) the major political and institutional challenges facing the Assembly raised in Santiago. Disagreements on the European side had mainly concerned whether or not the ceremony commemorating the 40th anniversary of the death of former President Salvador Allende should be of an institutional nature, and also whether or not there should be recourse to the procedure for voting by separate houses laid down in Article 15 of the Assembly's Rules of Procedure. As regards the Latin American component, the Santiago meeting had brought to the surface a genuine concern over internal cohesion within the Latin American component, which had suffered a strong ideological rupture when the principle it had held to of rotating appointments to its senior posts in the Assembly had been broken in Parlacen's favour. The Chair also emphasised the total lack of proper form demonstrated in the drafting and presentation of the Message to the Summit by Co-President Gloria Oquelí who, once negotiations had closed on the Message as a joint document to be presented by the two Co-Presidents in accordance with Article 17 of the Assembly's Rules of Procedure, had then proceded to negotiate unilaterally with other Members in her component an alternative unilateral text, which did not reflect the official positions adopted by the Assembly.

Finally the Chair said that he would contact the High Representative/Vice-President of the Commission Ms Ashton in due course to seek a suitable solution to the problem of follow up and implementation of resolutions and decisions adopted by the Assembly in Santiago, Chile. This was a matter that had remained unresolved since the Assembly's establishment in 2006. He would also discuss with her issues related to Article 20 (Questions for written answer) and Article 21 (Questions for oral answer) of the Assembly's Rules of Procedure.

A lively debate followed in which a great many of the Members present took part. The debate focused to a large extent on the repercussions for the EuroLat Assembly of the dispute between Argentina and the United Kingdom over sovereignty of the Islas Malvinas/Falklands (this term to be used in official documents in Spanish

while 'Falkland Islands' on its own should be used in official documents in English, in accordance with Annex II to the Treaty of Lisbon).

6. Exchange of views with Christian Leffler, Managing Director for the Americas, European External Action Service, on the outcome and follow-up of the First CELAC-EU Summit in Santiago, Chile (26-27 January 2013)

The Chair announced that Mr Leffler (Managing Director for the Americas) could not be present as he was away on a trip and he thanked the new Director for the Americas, Mr Roland Schäfer, for his willingness to appear before the delegation. He mentioned that the attendance at the Eurolat Assembly's plenary session in Santiago, Chile, of Baroness Ashton, High Representative of the Union for Foreign Affairs and Security Policy/Vice-President of the European Commission/Chair of the EU Foreign Affairs Council had been very much appreciated. He then gave the floor to Mr Schäfer. Mr Schäfer reported on the outcome of the First CELAC-EU Summit in Santiago, Chile, on 26 to 27 January 2013 immediately following the Sixth Ordinary Plenary Session of the EuroLat Assembly. Mr Schäfer also made special reference in his speech to the likely implications for EU-LAC relations of the future Transatlantic Trade and Investment Partnership Agreement between the European Union and the United States. Replying to criticisms by the Chair of the limited role given to Parliament and EuroLat in ministerial meetings during the Summit when compared to the role played by Parliament during ministerial meetings of the Rio Group and the San José Dialogue, Mr Schäfer announced that he would come back with specific proposals, both at political level (summit and ministerial meetings) and at administrative level (attendance by Parliament's Secretariat as observers to meetings of High Level Officials and COLAT/AMLAT meetings). In the course of the debate that followed, Ms Astrid Lulling, Quaestor, asked to put on record her satisfaction with the excellent treatment she had received following her illness during the Assembly's Plenary Session, the First EU-CELAC Summit and in the days following. She also thanked the staff of the EU Delegation in Santiago and of the Chilean Senate and, above all, the EP's Members and officials in Santiago, Brussels and Luxembourg.


7. Other business
