

Dear Ambassadors Nordlander and Danielsson,

As Sweden has taken over the Presidency of the European Union this month, we are writing to you to formally introduce you to the Human Rights and Democracy Network (HRDN) of NGOs. We are a group of over forty NGOs, all undertaking advocacy at an EU level, urging the EU to promote and protect all the rights set out in the Universal Declaration of Human Rights, both within Member States and in its relations with third countries.

Human rights obligations are enshrined in the treaty basis of the EU, and the EU has created a number of instruments to protect and fulfil human rights at home and abroad. However, we, as a network of NGOs, strongly believe that the EU can and should do more to ensure that it delivers effectively on these human rights commitments. The impact of EU human rights tools is not currently measured, and they sometimes appear to be viewed by the EU institutions as an end in themselves, rather than as a means to bring about change. In addition, internal and external mechanisms are often not consistent and coherent with each other.

The organisations within the network range from international NGOs to smaller organizations based in one EU Member State, but we have come together as an informal network to pursue common goals of influencing EU and member states human rights policies and the programming of their funding instruments to promote democracy, human rights, justice and sustainable peace. Through our membership, we have a worldwide presence, and within the European Union, we are members of the Civil Society Contact Group, which is an alliance bringing together eight large rights and value based NGO sectors acting in the public interest. A number of our members attended the very successful NGO forum in Stockholm on July 6 and 7 and we look forward to collaborating with you on follow up to this event.

We would be pleased to act as your key interlocutor for information sharing with civil society on human rights and democracy issues, and to support the Presidency in organisation of events and involvement of civil society in relevant policy work. We would also kindly request that HRDN be involved in any policy developments on human rights in regional and thematic council working groups, in addition to the monthly debriefs from COHOM and PSC which our member organisations attend.
