1. Additional own-initiative reports

In addition to the own-initiative reports on Disaster Prevention (COM(2009)82 - see item A.11. above), Adapting To Climate Change (COM(2009)147 - item A.12.) and Action Against Cancer (COM(2009)291 - item A.14.), **the coordinators decided to request the authorisation of the following two own-initiative reports:**

Decision

Owing to the apparent failure of the EU Action Plan aimed at halting the loss of biodiversity by 2010⁽¹⁾, the coordinators also decided to request the authorisation of an 'implementation report' on the implementation of major EU legislation with a bearing on the conservation of biodiversity.⁽²⁾

C. DECISIONS ON OTHER ISSUES

C.1. Draft calendar of ENVI meetings in 2010

Decision

The coordinators approved the draft calendar with the following modifications. The following isolated half-days were deleted:

- Monday 11 January
- Monday 1 February
- Tuesday 23 March
- Monday 10 May
- Monday 7 June
- Monday 28 June
- Monday 30 August
- Monday 11 October
- Monday 15 November
- Monday 6 December

The following isolated half-days were kept in the reserve:

- Tuesday 23 February
- Monday 1 March
- Monday 13 September

This results in a total of 45 half-days for ENVI meetings, plus 3 half-days 'in the reserve'; the use of the reserve days will depend on the effective workload.

The final calendar as adapted will be circulated to all ENVI Members and put on the ENVI website.

C.2. Point system for the allocation of reports and opinions

Decision

The coordinators

- **confirmed to apply the traditional ENVI point system which had successfully been applied during the 6th parliamentary term on a consensual basis,**
- **confirmed in particular that the number of points allotted to each group for the first half of the parliamentary term is equal to the number of its seats in the Environment Committee multiplied by two.**

C.3. Proposal to dispatch an EP ad hoc delegation to the U.S. Congress

Decision

The coordinators

- **agreed that an ad hoc delegation should be sent to the US Congress in order to endorse the political momentum for the Waxman-Markey clean energy and climate act (which had been passed in the House of Representatives on 26 June 2009⁽¹⁾) and the corresponding Kerry-Boxer bill which is to be introduced in the Senate in September⁽²⁾;**
- **instructed the chairman to write to the President of the European Parliament with a view to initiating the requisite steps for the urgent authorisation of an EP ad hoc delegation to the U.S. Congress, possibly at the end of October, depending on the availability of interlocutors;**
- **noted that the committee's request needed to be endorsed by a political group since only the groups had the right to propose ad hoc delegations.**

C.4. Stocktaking and unfinished business ('continuity' and 'discontinuity')

The papers for the meeting included

- a letter from President Buzek on screening of unfinished business and stocktaking of outstanding or potential legislation
- a note dated 13 July 2009 on 'Legislative challenges for the Environment Committee'

Decision

The coordinators

- **took note of a letter from the President of the European Parliament to all committee chairs;**
- **examined all pending files falling under the committee's remit;**
- **agreed that all the legislative procedures in relation to 16 pending 'active' files should be continued in the meaning of Rule 214;**
- **agreed that that the legislative procedure in relation to one file where Council had not adopted a common position although Parliament had adopted its first reading resolution in March 2004 should also be continued and that Ms Harms would be the rapporteur for that file⁽³⁾;**

- noted that there was no explicit request from any group to apply Rule 59 to any pending procedure;
- invited the chairman to inform the President of the European Parliament (cc to the chair of the conference of committee chairs) on the outcome of the coordinators' deliberations on the above in writing and to include listings of 'all significant outstanding legislative proposals and other initiatives from the European Commission' and of 'further proposals or other legislative action which the committee has already called for from the Commission in the recent past'.

C.5. Strategic committee priorities

Postponed.

C.6. Relations with the Agencies (EEA, EMEA, EFSA, ECDC, ECHA, FVO)

C.6.1. General matters and appointment of contact persons

Decision

The coordinators agreed to postpone the appointment of contact persons in order to explore options and to look for candidates within their groups.

C.6.2. EFSA Management Board - Parliament's involvement in the selection process

The papers for the meeting included a letter of 28 July 2009 from Mr Robert Madelin to Mr Jo Leinen on the selection of candidates to the EFSA Management Board.

Decision

The coordinators

- **asked, without prejudice to the future decision on the appointment of a contact person for relations with EFSA, Ms Liotard to follow the work of the Commission's 'Candidate Selection Committee' as an observer;**
- **emphasised that this appointment shall not prejudice in any form the European Parliament's position on the final list of candidates which has to be made available in accordance with Article 25 of Regulation 178/2002;**
- **invited Ms Liotard to inform the coordinators on a regular basis about the progress and the decisions taken in the Candidate Selection Committee;**
- **instructed the chairman to inform the Commission accordingly.**

C.6.3 ECHA - resignation of Mr Bernd Lange from ECHA Management Board - nomination of a successor

The papers for the meeting included letter of 15 July 2009 from Mr Lange MEP to Mr Jakl, Chairman of the ECHA Management Board.

Decision

The coordinators

- **took note of Mr Lange's resignation from his function as Member of the Management Board of the European Chemicals Agency as from 15 July 2009**
- **heard Ms Hassi who said that Mr de Roo, Parliament's second appointee on the ECHA Management Board, had informed her of his intention to resign, too, and that a letter of resignation was to be expected shortly;**
- **agreed that once a formal letter of resignation had been received also from Mr de Roo, Parliament's two representatives should be appointed jointly and for the full duration of the term of office as foreseen in Article 79(3) of the REACH Regulation (four years, renewable once);**
- **considered that an accelerated appointment procedure might be applied.**

C.7. Appointment of 2 ENVI representatives on the STOA panel

Postponed

C.8. Comitology and pharmaceuticals (droit de regard in the area of marketing authorisations for medicinal products)

The papers for the meeting included a letter from Mr Zourek to Mr Leinen and a letter from President Barroso to President Buzek.

Decision

The coordinators

- held an exchange of views in the presence of Ms Roth-Behrendt;
- agreed that in the light of the special circumstances applying to the authorisation of medicinal products shorter time-limits for parliamentary scrutiny could be applied;
- invited the chairman to consult the coordinators again once a concrete proposal from the responsible Commissioner was received;
- noted that subject to the coordinators' agreement the matter could then be settled by a formal agreement between the responsible Member of the Commission and the Chair of the parliamentary committee responsible (paragraph 9 of the agreement between the EP and the Commission laying down the procedures for the exercise of implementing powers)

C.9. Preparation of the Oral Question and resolution in view of COP-15

Decision

The coordinators

- agreed that in order to prepare collectively the Oral Question and the resolution on the European Parliament's position ahead of COP15, the coordinators of all the political groups should designate a Member of their group to follow the matter, and in particular to prepare the draft resolution to be submitted to the full committee;
- considered that once adopted the draft resolution could be tabled in the name of all those Members who were involved in the drafting process;
- agreed that the committee should adopt its draft resolution before the Environment Council taking place on 23 October 2009;
- invited the secretariat to circulate a detailed draft calendar for the preparation of the resolution.
