C. DECISIONS ON OTHER ISSUES

C.0. Cancellation of the 'reserve' meeting day on 16 November 2009

Decision

The coordinators agreed to the cancellation of the 'reserve' meeting foreseen for Monday 16 November 2009 from 15.00 to 18.30 hrs.

C.1. Arrangements for the preparation of the pre-Copenhagen climate change resolution

The papers for the meeting included

- a letter of 17 September 2009 from Mr Leinen to the President on the timing of climate change resolutions
- a letter of 23 September 2009 from Mr Leinen to Mr Reul, chair of ITRE
- a letter of 23 September 2009 from Mr Leinen to Ms Joly, chair of DEVE.

Decision

The chairman informed the coordinators of the outcome of his bilateral encounters with the chairs of DEVE and ITRE.

The coordinators noted in particular that

- (a) it had been agreed between Mr Leinen and Ms Joly that a limited number of core conclusions based on a draft resolution which had been adopted by DEVE would be tabled in the name of the DEVE chair by 1 October;**
- (b) following the bilateral meeting between Mr Leinen and Mr Reul a number of conclusions had been received informally by the chairman and that some of those conclusions would have to be streamlined with the ENVI draft resolution so as to avoid redundancies and contradictions, in particular as regards border adjustment taxes.**

[Note: The final vote in ENVI will take place on 19 October in Strasbourg.]

C.2. Strategic committee priorities

Decision

The coordinators agreed that the merits and shortcomings of the 6th Community Environment Action Programme (including the implementation of legislation stemming from the 6th EAP) should be evaluated with a view to preparing the future 7th Community Environment Action Programme as a long-term committee priority.

The evaluation of the 6th EAP should preferably take the form of visual, user-friendly presentations by the Commission to committee members. A strategy on the use of water in the context of climate change should be part of the priorities.

C.3. Relations with the Agencies (EEA, EMEA, EFSA, ECDC, ECHA, FVO)

C.3.1. Appointment of contact persons

Decision

The coordinators held an exchange of views and decided to take a final decision at their next meeting.

C.3.2 ECHA - resignation of Mr Bernd Lange and Mr Alexander de Roo from the ECHA Management Board - nomination of successors for a four year term

The papers for the meeting included

- a letter of resignation dated 5 July 2009 from Mr Lange
- a letter of resignation from Mr de Roo, received on 17 September 2009
- the Rules on the Designation by the European Parliament of Members of the Management Boards of the Specialised Agencies and Bodies.

Decision

C.5. Re-establishment of the Health Working Group

The coordinators agreed on the principle to re-establish the Health Working Group.

The coordinators noted that the initial remit of the Health Working Group was to follow the implementation of the Health Action Programme and to discuss any health issues that could not be discussed in the full committee due time constraints and bring, if necessary, those issues to the attention of the full committee.

The coordinators agreed to put forward possible additions to the Health Working Group's remit as well as names of candidates for the office of (two) co-chairs at their next meeting.

C.6. Cooperation with other committees

C.6.1. Information on AGRI own-initiative report on "EU Agriculture and Climate Change"

Decision

The coordinators took note of the fact that, on the one hand, the Committee on the Environment, Public Health and Food Safety had asked for authorisation to draw up a report on the Commission White Paper "Adapting to climate change: Towards a European framework for action" (COM(2009)147), and on the other hand, the Committee on Agriculture and Rural Development was seeking authorisation for an own-initiative report on "EU Agriculture and Climate Change".

- The coordinators held an exchange of views and came the conclusion that the Committee on Agriculture and Rural Development should be invited to draw up an opinion to the ENVI own-initiative report "Adapting to climate change: Towards a European framework for action (COM(2009)147)", in line with the fact that the Commission had simultaneously published an accompanying staff

paper "Adapting to climate change: The challenge for European agriculture and rural areas (SEC(2009)417)".

C.6.2. Involvement of ENVI in the AFET Working Group on EU/UN relations

Decision
