The Committee decided by unanimity to recommend the President to:

- challenge the validity of Council Decision 2010/252/EU ("Frontex / Sea borders") before the Court of Justice whilst inviting the Court to preserve the effects of the measure until a new legislative act has been adopted,
- challenge the validity of the draft Council Regulation on notification to the

Commission of investment projects in energy infrastructure (2009/0106/CNS),

- submit observations in a preliminary ruling in which an Italian judge is asking for an interpretation of Article 8 (ex Article 9) of Protocol no 7 on the Privileges and Immunities of the European Union in connection with Parliament's resolution of 5 May 2009 on the defence of the immunity and privileges of Aldo Patriciello, limited to the interpretation of the scope of Article 8 of the protocol.

22. Verification of credentials

The Committee decided by unanimity that the appointment of Jerzy Buzek to be member of an Honorary Committee for the erection of a monument at the Temple of the Divine Providence in Warsaw as a tribute of the victims of the plane crash of Smolensk, in which the Polish President Lech Kaczynski died together with 95 other persons, is compatible with the office of Member of the European Parliament, and respects the spirit and letter of Article 7 of Act of 20 September 1976 concerning the election of the Members of the European Parliament.

23. Request for defence of Mr Valdemar Tomaševski's parliamentary immunity
