Meeting of 5 July 2010, from 19.00 to 20.30  
STRASBOURG

The meeting opened at 19.08 on Monday 5 July 2010, with Klaus-Heiner Lehne (Chair) in the chair.

**1. Adoption of agenda**

The agenda was adopted.

**2. Chair's announcements**

The Committee had applied for authorisation to draw up an initiative report on the Green Paper: Corporate governance in financial institutions and remuneration policies.

The Committee would hold a hearing in October 2010 on collecting societies, with the presentation of the interim report of the Working Group on Copyright and in anticipation of the Commission's legislative proposal on the same topic at the end of 2010.

On a proposal from the coordinators, the Committee decided to appoint the following rapporteurs and rapporteur for opinion:

- Diana Wallis for the report on the Request for the defence of Mr Bruno Gollnisch's parliamentary immunity;
- Alexandra Thein for the report on the Green Paper: Corporate governance in financial institutions and remuneration policies;
- The Chair for an opinion on the Amendment of Regulation (EC) No 1060/2009 on credit rating agencies.

The Committee decided to ask for an opinion from the Legal Service on the legal basis for the Proposal for a Council Regulation on special conditions for trade with those

areas of the Republic of Cyprus in which the Government of the Republic of Cyprus does not exercise effective control (COM(2004)0466 final).

**3. Exchange of views with Stefaan De Clerck, Belgian Minister of Justice, on the priorities of the Belgian Presidency**

**6. Control by Member States of the Commission's exercise of implementing powers**

**7. Draft Commission decision on the adequacy of the competent authorities of Australia and the United States of America pursuant to Directive 2006/43/EC**

Following a presentation by József Szájer (standing rapporteur on comitology), the Committee unanimously accepted the request for early approval (15 votes in favour).
